## SUPPLY OF VARIOUS TREATMENT CHEMICALS ON-CALL BASIS

### 1. INTRODUCTION

Nigerian Agip Exploration Limited (hereinafter referred to as "NAE"), operator of OML 125 & 134, hereby invites reputable Chemical Company to apply to be considered for inclusion in the bid list for the proposed contract for the supply and monitoring of various treatment chemicals through the NipeX portal.

The work location is production facility in ABO deep offshore location of Nigeria. Company will require through this Contract an integrated service through a qualified Contractor that provides a quality chemical product and a proper service to ensure that the Company Key Performance Indicators (KPI) is achieved. It is foreseen that the contractor through this contract shall supply the chemicals required to treat our oil, gas and water streams/facilities. The chemical screening procedure will involve the performance of, daily chemical analysis, bottle testing/field trial (as the case may be) of each of the chemicals to be supplied.

Company's KPI that Contractor shall comply with through this contract include but not limited to the following::

No emulsion, No wax deposition, No scale deposition, No hydrate formation, H2S level less than 10ppm, Percentage of oxygen concentration not less than 20 parts per billion, Efficient control of subsea production systems, Percentage increase of flow rates while maintaining existing pipeline/flowline pressure, SRB values below 100 cfu/m and max. corrosion rate of 0.1mm/yr.

The proposed contract term will be for a period of Two (2) years with option of One(1) year extension. Contract will be awarded at the end of the tender exercise to the Two (2) lowest responsive applicants.

### 2. SCOPE OF WORK.

The Scope of work shall include but not be limited to the following activities:

Provide all the equipment, materials and personnel needed for the periodic optimization programs.

During execution of work activities COMPANY policies, standards and specifications shall be abided to.

Supply of chemicals on time and on call-off basis and according to Company's requirements

Perform all necessary tests in order to ensure proper performance of chemicals

When necessary, optimization of chemical treatment, adjusting the dosages in line with production changes

When necessary, continued optimization, improvement and implementation of the chemical program under the supervision of Company personnel

Provide trained personnel to assist the Company's Laboratory in the measurement and analysis of the most common parameters related to the chemical treatment

Submit the chemical reports as at when due and handling a comprehensive database for easy follow-up of chemical treatment

Tracking of system changes in order to adjust program accordingly

### 4. NIGERIAN CONTENT

Nigerian Agip Exploration Limited is committed to the development of the Nigerian Oil and Gas business in observance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

Contractors shall comply with the provisions of the NOGICD Act and all applicable regulations.

Bidders that do not meet the Nigerian Content criterion will not be allowed to participate in the next Tender Stage.

Pursuant to enactment of the NOGICD Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the schedule of the Act and any other target as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

Bidders are invited to express complete understanding and willingness to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act 2010.

Pursuant to the above, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act provisions/Schedule. Only bidders whose submissions are in compliance shall proceed to the next stage of the tendering process.

The following are some of the Nigerian Content requirements bidders are expected to comply with in their technical bid submission:

1. Demonstrate that the entity is a Nigerian company, Provide details of its Ownership Structure. Submit certified true copies of CAC form (C02 and C07) including Memorandum and Article of Association. Including evidence of being registered on the NCDMB NOGICD JQS.

2. Provide description of in-country committed infrastructure (asset, equipment, technical office, and administrative space, storage, workshop, assembly area, repair, and laboratory, testing, etc) in Nigeria (offices, equipment etc) to support this contract.

3. Demonstrate in-country sourcing of the base raw materials and chemicals.

4. Provide evidence of ownership of blending, testing and laboratory facility in Nigeria or MOA with in-country owners of such facility.

5. Demonstrate in accordance with the NOGICD Act 2010, a minimum of 90% in-country spend as specified in the Schedule A for this service, NCEC approval for this product and service category.

6. Provide description of Project-specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel in key areas, In line with NCD Human Capacity Development Initiative
