- c) If you are not listed in a product/service category but you are registered with DPR to do business, contact NipeX office at 30, Oyinkan Abayomi Street, Ikoyi Lagos with your DPR certificate as evidence for verification and necessary update.
- d) To initiate the NJQS pre-qualification process, access www.nipex-ng.com click on services tab followed by NJQS registration.

e) To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

# 4. NIGERIAN CONTENT

Bidders are invited to express complete understanding, willingness and commitment to develop in-country capability and capacity for related items in compliance with the Nigerian Oil and Gas Industry Content Development Act (NOGICD Act, 2010).

Pursuant to the above, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act provisions and Schedule. Only bidders whose submissions are in compliance shall proceed to the next stage of the tendering process

The following are some information/documentation that will be required for submission at the ITT stage:

- Demonstrate that the entity is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work. Such companies must show evidence of joint venture binding memorandum of agreement (MOA) duly signed by the CEO of both companies including the following:
  - Be governed by the laws of the Federal Republic of Nigeria
  - The scope of work and responsibilities each party will perform in executing the job
  - The lead bidder
  - evidence or plans of physical operational presence and set-up in Nigeria
- 2. International or multinational company working through a Nigerian subsidiary must demonstrate that a minimum 50% of equipment to be deployed for execution of work shall be owned by the Nigerian subsidiary by providing a list of equipment for this tender and indicating those that will be owned by the Nigerian subsidiary
- 3. Tenderer to provide verifiable evidence of ownership and name of the nominated vessel or binding memorandum of agreement and letter of offer between vessel owner and tenderer. The Vendor should be categorized under 'CATEGORY A/AA' in the NCDMB marine vessel categorization report"Nigerian Content Plan with detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that are involved in executing the service;
- Details of Company ownnership and shareholding structure with certified true copies of CAC forms CO2 and CO7, including company memorandum & article of association and other evidence of entity's incorporation;
- Current and in-place organization structure with detailed experience and skills of key management personnel with names;
- Evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerian nationals and the percentage of the total workforce that are Nigerians;
- Detailed training plan for the service which must be related to the service to be carried upon identification of Capacity Gaps
- Detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, storage facilities etc) in Nigeria to support this contract or submit a credible and verifiable plan towards setting-up;
- Details of the applicant's relationship with local suppliers and service providers (e.g. in the management of the logistic, personnel);
- Your detail training plan for the Nigerian crew or cadets supported by their CVs and stating the training disciplines, manhours and duration on
- Provide the list and percentage of your vessels crew that are Nigerians supported by their CVs.
- 12. Evidence of compiance with Nigerian Flag registration and Nigerian Crew.
- 13. Provide three-year plan for increasing the Nigerian content of your vessel crew.

#### NOTE: Only Nigerian Companies are qualified for this service.

- Bidders shall be requested to provide evidence to show their compliance with the above listed requirements at the ITT stage.
- Failure to meet the Nigerian Content requirements is a "FATAL FLAW."
