Chevron Nigeria Limited (Company) invites interested and prequalified companies to this tender opportunity for the provision of operating and maintaining of various Logistics Support Equipment in its swamp locations, offshore fields and any other locations as required to support Company's ongoing oil and gas production activities. The proposed contract term is 3 (Three) years with an option of 1 (one) year extension.

### SCOPE OF WORK:

**Anticipated Commencement Date: Second (2nd) Quarter 2019**

The scope of work for the service includes but is not limited to the following:

Contractor shall provide Crawler Cranes, Mobile Crane, and any Ancillary equipment, that is acceptable by Company, on call-out basis, to support Escravos Operations. These include, but are not limited to:

1. 275 Ton Crawler Crane with maximum boom length, Auxiliary winch with year of manufacture not earlier than 2010
2. 250 Ton Crawler Crane with maximum boom length, Auxiliary winch with year of manufacture not earlier than 2010
3. 120Ton Grove Mobile Crane with maximum boom length, Auxiliary winch with year of manufacture not earlier than 2010
4. 100Ton Grove Mobile Crane with maximum boom length, Auxiliary winch with year of manufacture not earlier than 2010
5. 90Ton Grove Mobile Crane with maximum boom length, Auxiliary winch with year of manufacture not earlier than 2010
6. 80Ton Grove Mobile Crane with maximum boom length, Auxiliary winch with year of manufacture not earlier than 2010
7. 60Ton Grove Mobile Crane with Maximum boom length, Auxiliary winch, with year of manufacture not earlier than 2010
8. Telescopic Forklift 3.5T (Telehandler forklift) with Solid type tyres with year of manufacture not earlier than 2010
9. Truck and Trailer-30- 60Ton High bed or Lowbed with year of manufacture not earlier than 2010

12. Qualified Crane Operator Class A (available for needs beyond those in items 1-11)

### A. FURTHER SPECIFICATIONS AND SERVICE CONDITIONS:

1. Crawler Cranes - Contractor shall provide all Crawler Cranes with Operators. The Operator positions shall be occupied by rotational prequalified persons.
2. Contractor shall provide Rigging Services Class 1 to Class 4. Rigging services shall be provided with rotational certified class 1 to Class 4 riggers.
3. Contractor shall provide Trailer Truck services with truck drivers. The trucking services shall be provided with rotational prequalified heavy duty experienced drivers.
4. Mobile Cranes- Contractor shall provide all mobile cranes with rotational prequalified crane operators.
5. Telescopic Forklift - Contractor shall provide telescopic forklift with rotational prequalified operators.
6. Provision of other related equipment as specified in a Service Order duly executed by Company and Contractor.
7. Services provided will be requested by Company using Service Order.
8. Services provided will be for twenty-four (24) hours availability while on call-out.
9. Contractor shall provide all lubricants required for safe and efficient running of equipment.
10. Delivery and Redelivery location for the equipment and personnel shall be Chevron Dock, Warri or as specified in Service Order.
11. Contractor shall receive compensation for the number of day(s) Service is provided, as specified in relevant activity log duly endorsed by Company's Representative.
12. Contractor is responsible for removing own equipment from Company's area of operation at the expiration of Service Order.
13. Contractor shall ensure that equipment provided to perform services are compliant with Company's Health, Environment & Safety, and Marine Safety, Reliability & Efficiency standards.

### B. OPERATOR CERTIFICATION / QUALIFICATION

All equipment operators are to have valid certifications as detailed below:

1. Crane operators - Certification from Company Warri Training Center
2. Forklift operator - Certification from Company Warri Training Center
3. Trailer Driver National Driving License- Class F

Costs of all operator Certifications and Recertification (at Warri Training Center and elsewhere) are to be borne by contractor without recourse to Company

Pursuant to enactment of the NOGICD Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the schedule of the Act and any other target as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

- E. State proposed total scope of work to be performed by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidences of well-equipped offices and workshop; attach past experience of such patronage.
- F. - K. Provide evidence of MOU with OGTAN registered trainer to conduct classroom module of training and on the job attachment
- L. Provide human capacity building development plan including budget which must be minimum 10% of project man-hours or cost. Training will be targeted at developing capacity other than bidder's personnel. Trainees will be nominated from a database maintained by NCDMB and the services of OGTAN registered trainers utilized to cover classroom modules.
- M. Provide details of equipment ownership.
- N. Bidders (Vendors, Original Equipment, Manufacturers-OEMs, and EPC Contractors) are required to present Nigerian Content Equipment Certificate (NCEC) issued by Nigerian Content Development and Monitoring Board (or evidence of application for the certificate) in respect of any components, spares, equipment, systems and packages to be used in the proposed project under tender.
- O. All Bidders for a project/contract/service with a completion period of 12 months or more are required to submit as part of the Nigerian Content requirement, a signed Memorandum of Agreement (MOA) between it and one of the research and development (R&D) Clusters established by the Nigerian Content Development &

Monitoring Board (NCDMB). The MOA shall be relevant to the project and shall indicate how the Bidder intends to use the relevant R&D Clusters during project execution.
