1. INTRODUCTION:

Chevron Nigeria Limited invites interested and prequalified companies for this tender opportunity for the Provision of Anchor Handling Tug & Supply (AHTS) Vessel in support of NNPC/CNL Joint Venture operations. The proposed contract shall be awarded for a two (2) year primary term and an optional one (1) year extension

2. SCOPE OF WORK:

The scope of work for the services includes but not limited to the following:

- Provision of Anchor Handling Tug & Supply Vessels in support of Chevron Nigeria/Mid Africa operations at Escravos, Eastern operations, and any other Company area of operations.
- Vessel shall be fitted for oil field support services and related duties.
- Vessel shall have a Master and full complement of officers and crew, all of whom shall be competent and capable of carrying out the Services.
- Vessel shall be self-catering, i.e. meals and bunks should be provided on the vessel by the contractor
- Provision of related/complementary services as advised by company using service order.
- All other standard vessel requirements.

3. MANDATORY TENDER REQUIREMENTS:

- To be eligible for this tender exercise, interested bidders are required to be pre-qualified and 'live' in the **3.08.01 (Tugs/ROV Support/Diving Support Vessels)** category in NipeX Joint Qualification System (NJQS) database. All successfully **pre-qualified and 'live'** bidders in this category by the bid close date will receive Invitation to Technical Tender (ITT).

- To be eligible, all tenders must comply with Nigerian Content requirements in the NipeX system

4. NIGERIAN CONTENT REQUIREMENTS

Chevron Nigeria Limited is committed to the development of the Nigerian Oil and Gas business in observance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

Pursuant to enactment of the NOGICD Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the schedule of the Act and any other target as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

Contractors shall comply with the provisions of the NOGICD Act and all applicable regulations. Bidders that do not meet the Nigerian Content criterion will not be allowed to participate in next Tender Stage

The following are the Nigerian Content requirements bidders are expected to comply with in their technical bid submission.

- Tenderers shall be categorized A/AA vendors and own the nominated Anchor Handling Tugs & Supply Vessel (AHTS), duly categorized as Nigerian owned in the latest NCDMB NOGIC JQS marine vessel categorization report.

- Demonstrate that the entity is a Nigerian indigenous company with greater than or equal to 51% Nigerian shareholding. Provide details of its Ownership Structure. Submit certified true copies of CAC form (CO2 and CO7) including Memorandum and Article of Association. Including evidence of being registered on the NCDMB NOGIC JQS.
 - Furnish details of company ownership and shareholding structure. Also submit clear photocopies of your CAC Forms CAC 2 and CAC 7.
 - Provide evidence of the percentage of 1) key management positions that are held by Nigerians and 2) total work force that are Nigerians. Also, show overall percentage of work to be performed by Nigerian resources relative to total work volume.
 - Provide a Nigerian Content Execution Plan with a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that will be involved in executing the work. Also provide details of Nigerian Content contact or manager.
 - State proposed total scope of work to be performed by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidences of well-equipped offices and workshop; attach past experience of such patronage.
 - Provide evidence of domiciliation of project management and procurement centers in Nigeria with physical addresses (not P.O. Box).
 - Location of in-country facilities, (Equipment, storage, workshops, repair & maintenance facilities and, testing facilities).
 - Contractor must be willing and able to provide evidence of maximization of made in Nigeria goods and services.
 - In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

Only bidders who are **pre-qualified and 'live'** with NJQS Product/Category **3.08.01 (Tugs/ROV Support/Diving Support Vessels)** by **16:00 Hours, Friday, May 08, 2020** being the advert close date shall be invited to submit technical bid.

Additional Information:

- Suppliers eligible for this tender opportunity are expected to be prequalified in NJQS under this product/service category.
- The Invitation to Tender (ITT) and any further progression of this tender shall be via NipeX.
- All costs incurred in preparing and processing NJQS prequalification shall be to the contractor's accounts.
- Suppliers eligible for this tender opportunity are expected to meet the requirement of the Nigerian Maritime Administration and Safety Agency, NIMASA.
