INTRODUCTION:

Chevron Nigeria Limited (CNL), operator of the Nigerian National Petroleum Corporation (NNPC)/CNL Joint Venture, invites interested and prequalified companies to this tender opportunity for the supply of Oil Country Tubular Goods (OCTG) to support Joint Venture exploration and drilling projects

The proposed contract term is 2 (two) years with an option of 1 (one) year extension.

SCOPE OF WORK:

Anticipated Commencement Date: First (1st) Quarter 2020.

The scope of work for the service includes:

- Manufacture and delivery of Casing, Tubing, Pups, Crossovers and related equipment.
- Handling and Storage Capability of procured goods.
- Maintenance of a detailed inventory of company equipment stored within contractor's base
- Bidder's shall provide a detailed schedule plan from manufacture to delivery at Contractor's base.
- Contractor will supply Quality Plan outlining procedures to ensure that Company receives equipment that has been properly prepared for utilization. Dedicated QA personnel will be supplied by contractor to ensure rigorous adherence to Contractor's Quality Plan. Quality Plan will define shop equipment required to make up and test equipment prior to shipment offshore
- Threading of pipes

NIGERIAN CONTENT REQUIREMENTS:

CNL is committed to the development of the Nigerian Oil and Gas business in accordance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

Pursuant to enactment of the NOGICD Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the schedule of the Act and any other target as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

Interested bidders shall comply with the provisions of the NOGICD Act and all applicable regulations. Bidders that do not meet the Nigerian Content criterion will not be allowed to participate in the next tender stage

The following are the Nigerian Content requirements bidders are expected to comply with in their technical bid submission.

- Only bidders who own in-country threading facility for small OCTG shall bid for this work scope
- Demonstrate that the entity is a Nigerian registered company, defined as a company registered in Nigeria in accordance with the provision of Company and Allied Matters Act. Provide details of its Ownership Structure. Submit certified true copies of CAC form (C02 and C07) including Memorandum and Article of Association and registered on the NCDMB NOGIC JQS.
- Provide evidence of in-country committed facility not limited to threading facility for small OCTG, administrative office, and warehouse for equipment, tools & spare parts storage and workshop.
- Demonstrate key Management positions that are Nigerian Nationals and the percentage of the Company total workforce (direct and in-direct employees) that are Nigerians with Cvs.
- Provide evidence of 50% Nigerian ownership of all equipment to be deployed for this project.
- Tenderer shall demonstrate in accordance with the NOGICD Act 2010, a minimum of 95% in-country Man-hour as specified in the Schedule A for this service.
- Provide description of how bidder would maximize the utilization of Nigerian resources (materials, goods and services) in the execution of this contract. Submit the list of goods, raw materials and equipment of Nigerian origin to be procured.
- Provide a description of Project-specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel in key areas. In line with NCD Human Capacity Development Initiative, Tenderer to provide details on contract-specific training man-hours for Nationals to feed the National skill pool.
