INTRODUCTION:

Chevron Nigeria Limited, Operator of NNPC/CNL Joint Venture, invites interested and prequalified companies for this tender opportunity for the Provision of Wireline Logging Services to support Drilling, Completions and Workovers for JV Operations in Nigeria in 2020 - 2022.

The contract is proposed to span a period of two (2) years with a possible optional term of one (1) year duration

SCOPE OF WORK:

The scope of work for the services includes but not limited to the following:

- o Packages of latest technology open hole and cased hole wireline logging units and tools for oil and water base mud systems inclusive of high pressure and temperature tools for 6" to 17-1/2" hole sizes.
- o Packages of latest technology in open hole and cased hole wire line logging units and tools for oil and water base mud systems inclusive of high pressure and temperature tools for 6" to 17-1/2" holes sizes.
- o Packages of latest technology Logging tools, inclusive of spectral gamma ray, elemental composition logging, high resolution array resistivities, neutron, density, multi-pole sonic, borehole imaging, Nuclear Magnetic Resonance logging, wire line coring and Vertical Seismic Profiling. Must have capability to collect formation pressure, fluid sampling tools and multiple PVT quality samples.
- o Packages of the latest technology wire line tools for cased hole operations inclusive of gamma ray, neutron, and collar locator depth correlation; gamma ray rated for perforating and packer setting service; packer setting tools; bridge plugs for tubing & casing sizes from 2-7/8" thru 4-1/2"; perforating guns with charge and gun system performance as per API RP-43 5th Edition Section I procedures for hole punch, big hole and deep penetrating charges for tubing and casing sizes from 2-7/8" thru 9-5/8"; and chemical and explosive jet cutters for tubing sizes from 2-7/8" thru 4-1/2". The complete production logging tool string including sigma and oil saturation from elemental spectral stripping techniques. A complete set of cement evaluation devices, including a slim hole kit for through tubing applications.
- o Hardware and software to transmit real time directly to COMPANY's Lekki Office, and Port Harcourt/Onne Port bases. The COMPANY shall provide the data link between the rig-site and the remote locations; CONTRACTOR shall provide the hardware and software.
- o Wireline Service Coordinator(s) for supervising the CONTRACTOR's field operations at COMPANY bases in Lekki and/or Port Harcourt/Onne Port. Duties shall be inclusive of directing the movements of logging tools, supervising personnel as required for the field-based operations. In addition, he shall be required to recommend, and plan the execution of all cased hole wire line operations and consult with COMPANY personnel during operations to design such programs as may be directed by the company. The Wireline Service Coordinator must be an expert in logging operations with at least 5 years experience specific to Wireline logging.
- o Senior Logging engineers with a minimum of 7 years experience, of which 2 of the past 5 years are associated with offshore wells.
- o Wireline Operators with a minimum 7 years experience, at least 2 years of which associated with offshore wells.
- o Ability to construct a Wireline Service Shop at COMPANY base in Port Harcourt/Onne Port for performing detailed electronics checks and routine servicing of logging tools.
- o Fulltime Lagos-based Wireline Technical Services Representatives: experts in well logging operations with a minimum of ten (10) years logging experience, required to consult with COMPANY personnel during operations to design and execute well logging program as per COMPANY direction.
- o Dedicated Wireline Tool Maintenance Technicians to redress/maintain Wireline tools kept in Port Harcourt or Onne.
- o Complete listing and specifications of CONTRACTOR-owned Wireline equipment currently available in Nigeria. List to include:
 - o Types, sizes and dimensions of logging units, complete inventory of all CONTRACTOR's Wireline logging supplies, equipment and tools.
 - o Open hole PVT well site acquisition and validation services

MANDATORY TENDER REQUIREMENTS:

NIGERIAN CONTENT:

- B. Furnish details of company ownership and share holding structure. Also submit clear photocopies of your CAC Forms CO2 and Co7
- C. Provide evidence of the percentage of 1) key management positions that are held by Nigerians and 2) total work force that are Nigerians. Also, show overall percentage of work to be performed by Nigerian resources relative to total work volume.
- D. Provide a Nigerian Content Plan with a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that will be involved in executing the work. Also provide details of Nigerian Content contact or manager.
- E. State proposed total scope of work to be performed by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidences of well equipped offices and workshop; attach past experience of such patronage.
- F. Specific to this project, provide detailed plan for staff training and development on engineering, project management and procurement (including all software to be used, number of personnel, name of organization providing such training and evidence of past training record) for Nigerian personnel including description of any specific programs in place for transfer of technology and skills to indigenous businesses and Nigerians over the next five (5) years.
- G. Provide evidence of domiciliation of project management and procurement centers in Nigeria with physical addresses (not P.O. Box).
- H. Location of in-country facilities, (Equipment, storage, workshops, repair & maintenance facilities and, testing facilities).
- I. Contractor must be willing and able to provide evidence of maximization of made in Nigeria goods and services.
- J. Provide details on any other Nigerian Content initiative your company is involved in.
- K. Provide evidence of MOU with OGTAN registered trainer to conduct classroom module of training and on the job attachment.
- L. Provide human capacity building development plan including budget which
