#### 1. INTRODUCTION

#### 2. SCOPE OF WORK

Contractor is required to provide integrity inspection on the FPSO and SPM buoy topside process/utility equipment and facilities, hull shell, tanks, hull internals, and hull primary structures. The service shall include but not limited to:

- C. Provision of Routine Nondestructive Examination (NDE) Services

- E. Surface Preparation Prior to Inspection

- H. Management of inspection data and maintenance of Inspection data management tools
- I. Provision of Confined Space Entry (CSE) Activities
- J. Provision of Ad hoc Offshore Inspection Activities
- K. Provision of Summary reports of Inspection activities and
- L. Other support services

#### 3. MANDATORY REQUIREMENTS

## 4. NIGERIAN CONTENT

Company is committed to the development of the Nigerian Oil and Gas business in compliance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian oil and gas industry shall be consistent with the level set in the Schedule to the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

NNPC/EEPNL PSC requires their Contractors to comply with the Act, its attached Schedule and any applicable regulation developed by the Nigerian Content Development Monitoring Board.

Nigerian Content (NC) in the Nigerian oil and gas industry is defined as:

"The quantum of composite value added to or created in the Nigerian economy by a systematic development of capacity and capabilities through the deliberate utilization of Nigerian human, material resources and services in the Nigerian oil and gas industry."

"Nigerian company" is a company formed and registered in Nigeria in accordance with the provisions of Companies and Allied Matters Act with not less than 51% equity shares by Nigerians.

Bidders shall consider Nigerian content as an important element of their overall project development and management philosophy for project execution.

#### As part of their technical tender submissions, Tenderers shall:

- Provide evidence of company Ownership Structure form CO2 and CO7, registration on NOGIC JQS and DPR certificate.
- Detailed description of the location of in-country committed facilities & infrastructure (Technical/Administrative offices) in Nigeria to support this contract.
- In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- Submit Tenderer's corporate organizational and project/contract specific organogram.
  CV's of all personnel (NDE/NDT Technician2, NDE/NDT Technician1, Rope Access Level2 Technician, Rope Access Level1 Technician, NACE Certified Coating Inspector, Helper, Radiographic Testing Technician, AET Technician, GWT Level1.5, GWT Level1, Pulsed Eddy Current Level II Insp, TOFD Technician, Onshore Integrity/Inspection Support personnel and others as stated in the scope of work) listed in the project organogram should be submitted. For any position to be occupied by expatriate, tenderer shall provide evidence to obtain expatriate quota approval granted by NCDMB before any expatriate is deployed to execute this work scope".
- Provide evidence of at least 50% Nigerian ownership of Digital Radiographic Testing Equipment, Automated Ultrasonic testing equipment, Guided Wave UT Equipment, Rescue Kit, Personnel Rescue Gear, Gas Sniffer, Leak Test Inspection Equipment, Magnetic Particle Testing Inspection Equipment, Dye Penetrant Testing Inspection Equipment, Eddy Current Testing Inspection Equipment, Ultrasonic Testing Equipment, Radiographic Portable Isotope Container, Radiography Exposure Equipment services and others as stated in the scope of work.
- Provide Category C NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) issued by Nigerian Content Development and Monitoring Board in respect of Nigerian ownership of above-mentioned equipment.
- All procurement of consumables shall be procured from a local manufacturing vendor with a valid category ANCEC along with MOA.

Tenderer's failure to comply with the NOGICD Act or demonstrate commitment to Nigerian Content development will result in Tenderer's disqualification.
