TENDER OPPORTUNITY DREDGING WORKS IN THE NIGER DELTA (CAPITAL AND MAINTENANCE DREDGING)

1. INTRODUCTION

The Nigerian Agip Oil Company Limited (NAOC) intends to put in place an open contract for dredging activities in its OMLs 62 and 63.

The proposed contract shall cover a period of two (2) years plus one (1) year optional extension.

NAOC therefore uses this medium, to inform suitable and reputable companies having requisite experience and resources for the execution of projects of this magnitude, to register or update their registration with NipeX for consideration in the subject opportunity.

2. SCOPE OF WORK

The Scope of Work of this Contract shall include but not limited to:

a. Pre and Post Dredge mandatory Joint inspection:
This shall be carried out with the contractor, community/landlords representative and NAOC. Contractor shall carry out detailed survey of the site to determine actual site situation, which shall include setting out limit of dredging. Contractor shall carry out joint post dredged survey to confirm completion of dredging works at site.

b. Community and Security settlement:
Contractor shall be responsible for settlement of community and community related matters, security of his equipment, personnel and the entire work site. Contractor shall be required to harmonize relations with the host Community prior to mobilization to site.

c. Mobilization to site:
Contractor shall mobilize 18" Suction cutter dredge for the work. Mobilization to site shall include ancillary equipment (Bulldozer/swamp buggy and excavator) to facilitate speedy execution of the project. Prior to mobilization to site, all equipment to be utilized for the execution of the project shall undergo inspection and be certified to be in good condition by the company representative before mobilization of such equipment to site.

d. Bush clearing:
The proposed slot and access canal may require bush clearing before any form of excavation commences for capital dredging.

e. Dumpsite:
Contractor shall prepare dump site within the perimeter of NAOC acquired area, for containment of dredged spoils/materials. All necessary steps shall be taken to maintain and prevent damage to third party property in areas not acquired. Consequently, contractor shall construct bund wall with water box within the acquired area to contain dredged materials, and effluent water shall be channeled to pass through acquired areas back to the canal without any interference to third party property.

Bulldozers and excavators mobilized for the construction of the bund wall shall remain on site throughout the project duration for regular maintenance of the dump site.

f. Dredging of location slots for drilling purposes:
i. Location dredging is measured in volumes of dredge (cubic metres), which is greatly dependent on the type of the location.
ii. Single well layout is typically 100m x 130m while cluster (two wells or more) is typically 130m x 150m as a minimum.
iii. Grab excavation for floatation of the entire slot/access canal area
iv. Suction cutter dredging of the area to achieve final depth. Dredged material shall be hydraulically transported through floating hoses/pipes and shorelines to designated and approved dump sites.

g. Dredging of access canals:
Access canal dredging is also measured in dredge volume and can include grab crane excavation as well as suction cutter excavation. Other activities that may be required include water hyacinth removal and clearing of overhead hanging vegetation.

h. Contractor responsibility:
i. Contractor shall carry out all activities in compliance with the scope and all applicable Specifications, Codes and Standards.
ii. Contractor shall conduct a detailed site survey, in order to be sure of the scope of work.
iii. Provide suitable river craft, a covered speedboat with double 75 HP Outboard engine exclusively for the movement of NAOC Site Representative for inspection and supervision of the project.
iv. Contractor is also responsible for providing all equipment, qualified personnel and any necessary ancillary equipment for the execution of the work.
v. Contractor shall submit a daily & weekly progressive report (including photo report) to the NAOC representative.
vi. Contractor shall submit the final project report & as-built-drawings within a week of project completion.
vii. Contractor shall be responsible for the welfare & accommodation of all her

viii. Contractor shall ensure that all the activities shall be carried out in compliance with NAOC, National and International Safety Standard and Codes.

ix. Contractor shall be responsible for the making a Healthy, Safe & tidy environment at all times during the project execution.

x. Contractor shall be responsible for the provision of necessary PPE for all personnel on site during work execution.

xi. Contractor shall be responsible for any issues arising from Host Community in relation to the dredging and security matters at site.

xii. The contractor shall be responsible for the post dredge site restoration at the completion of all works

xiii. The contractor shall be responsible for compensation in a case of default/damages to farmland, ponds, vegetation etc to affected community

xiv. Submission of the final post dredge report including echo roll of bathymetric survey and As-built drawings.

3. MANDATORY REQUIREMENTS

a) To be eligible for this tender exercise, interested Contractors are required to be pre-qualified in the 3.06.05 – Dredging Services (Product/Services) in NipeX Joint Qualification System (NQS) database. All successfully pre-qualified suppliers in this category will receive Invitation to Technical Tender (ITT).

b) To determine if you are pre-qualified and view the product/service category you are listed for: Open www.nipexng.com and access NQS with your log in details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click supplier product group.

c) If you are not listed in a product/service category you are registered with DPR to do business, contact NipeX office at 8/10, Bayo Kuku, Street, Ikoyi Lagos with your DPR certificate as evidence for verification and necessary update.

d) To initiate the JQS pre-qualification process, access www.nipexng.com to download application form, make necessary payments and contact NipeX office for further action

e) To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

4. NIGERIAN CONTENT

Bidders are invited to express complete understanding and willingness to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act 2010. Pursuant to the above, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act provisions/Schedule. Only

bidders whose submissions are in compliance shall proceed to the next stage of the tendering process.

The following are some of the information/documentation that will be required for submission at the ITT stage:

1. Demonstrate that entity is a Nigerian-registered company. only Nigerian indigenous companies with <51% equity shareholding are allow to bid for onshore tender as state in the Nigerian Oil & Gas Industry Development Act, 2010 that onshore tenders are exclusively reserved for Nigerian indigenous companies. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc) and other evidence of entity's incorporation, shareholding & ownership structure in Nigeria.

2. Provide detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, technical office, and administrative space, storage, workshop, assembly area, repair & maintenance, testing, laboratory, etc) in Nigeria to support this contract or submit a credible and verifiable plan towards setting-up.

3. Provide a project-specific organogram showing Names and Nationalities of all key personnel that will execute the work scope for this service. CV's of these personnel should also be submitted. For any position to be occupied by Expatriate personnel, tenderer shall commit to obtaining expatriate quota approval from NCDMB before project execution.

4. Has tenderer provided a project-specific training, man-hour budget, skill development and technology transfer plan for Nigerian personnel or indigenous business including evidence of past performance on training and development for Nigerians nationals & indigenous business? Has tenderer an MOA with an OGTAN member?

5. Provide evidence of Nigerian content equipment certificate or acknowledged copy of application for NCEC not older than 4 months from its application.

6. Provide a detailed procurement plan with Goods & Materials to be procure from Nigerian vendor with evidence of a binding MOA with such vendors. Provide name, address and type of goods and services to be supplied by the Nigerian subcontractors.
