#### **SCOPE OF WORK** 2.

The Scope of Work shall include but not limited to the procurement and transportation of line pipes to all NAOC sites in Land and Swamp Areas as well as (if required) warehouse and consignment services.

#### **MANDATORY REQUIREMENTS** 3

To be eligible for this tender exercise, interested contractors are required to be registered in Pipe and Tubes 2 .01.01 in the NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified suppliers in these categories will receive Invitation to Technical Tender (ITT).

#### 4 **NIGERIAN CONTENT**

Bidders are invited to express complete understanding, willingness and commitment to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act, 2010 and. Insurance ACT 2003 Consequently, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act.

For Line Pipes; In line with the requirement of the NOGICD Act 2010 for first consideration to available goods and services in Nigeria, the procurement of line pipes (to be either free-issued or as company provided item) shall only be through an exclusive project acceptable vendors list (AVL) compiled from NCDMBapproved line pipe mills investors only (Brentex, SCC, and Yulong)

For OCTG; In line with the requirement of the NOGICD Act 2010, for the procurement of OCTG, first consideration shall be given to Nigerian companies that have demonstrated evidence of ownership of pipe threading mill in-country.

The documentation for evaluation shall include but not be limited to the followina:

1. Demonstrate that the entity is a Nigerian indigenous company, Provide details of its Ownership Structure. Submit certified true copies of CAC form (CO2 and CO7) including Memorandum and Article of Association. Including evidence of being registered on the NCDMB NOGICJQS.

2. Provide description of in-country committed infrastructure (asset, equipment, technical office, and administrative space, storage, workshop, assembly area, repair, and laboratory, testing, etc) in Nigeria (offices, equipment etc) to support this contract.

3. Tenderer shall provide detailed description of:

(a) For line pipes: Evidence of committed infrastructure incountry for the manufacturing of line pipes

(b) For OCTG: evidence of committed infrastructure of pipe threading mill in-country

**NOTE:** Non-compliance with Nigerian content requirements is a FATAL FLAW
