SCOPE OF WORK

SLICKLINE EQUIPMENT RENTALS AND SERVICES for NAOC wells in land and swamp areas.

The Slickline Service includes the following stages:

Co-operation with slickline service COMPANY to define slickline equipment characteristics (planning phase) in case of highly deviated well with high dog log severity in cased hole operations:

Fluid sampling operations to collect downhole sample Setting and recovering Wireline down hole tools;

Calibration of string;

Tubing patch (Straddle packer installation);

Tubing cleaning (Brush);

Tubing buckling expansion (Swaging tool);

Acquiring and interpreting field data;

Closing and opening of Sliding Side Door

Restriction confirmation in tubing string

Tubing punch and perforation

Fishing operation

Gyro survey

Preparing a final Job Report with remarks and assessment of the work carried out and an indication of whether the targets set by the program have been reached or not.

The slickline application is ran through wide range of different completion types for 2-3/8" - 7" tubing sizes in vertical, deviated and horizontal wells.

Failure to meet any of these requirements shall lead to outright disqualification.

CONTRACTOR shall conform to ISO 9000 series International Standard. All the activities shall be carried out with minimum impact on the environment and maximum care of health and safety of all concerned, directly or indirectly, with the activities.

Bidders are invited to express complete understanding, willingness and commitment to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act, 2010 and. Insurance ACT 2003 Consequently, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act.

The documentation for evaluation shall include but not be limited to the following:

- 1. Provide evidence of company Ownership Structure form CO2 and CO7, registration on NOGIC JQS and DPR certificate.
- 2. Detailed description of the location of in-country committed facilities & infrastructure in Nigeria to support this contract.
- 3. Provide a project-specific training.
- 4. Submit Tenderer's corporate organizational and project/contract specific organogram.
- 5. Provide evidence of at least 50% Nigerian ownership of slickline equipment
- 6. Provide Category C NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) issued by Nigerian Content Development and Monitoring Board in respect of the mentioned equipment.
