1.0 INTRODUCTION

SCOPE OF WORK/SERVICE REQUIREMENTS

Vendor shall provide ancillary services to support Company's operations and in accordance with Company drilling programmes, the specifications contained in the contract and/or otherwise as directed by Company.

The provision of services and execution of the work - as summarized - shall be:

- By carrying out services in accordance with requirements of Contract on a planned and consistent basis.
- By the provision of Contractor's Personnel full time, to provide planned and unplanned services on an immediate basis
- By provision of Contractor's items full time, to provide planned and unplanned services on an immediate basis.
- By performing activities on or in connection with the well(s), utilizing Contractor's Items and/or Personnel on a Call-Out basis at various notice periods.
- By performing activities in connection with the drilling, completion, testing and suspending, Reentry existing wells or abandoning well operations utilizing Contractor's Items and/or Personnel at locations other than drilling rig. Immediately stopping drilling and notifying Company if formations are encountered which reasonably appear to be oil or gas bearing and/or of lithological importance. Immediately notifying Company if circulation is lost, impenetrable formation is encountered and, in the meantime, exerting every reasonable effort to overcome such difficulties according to Good Oilfield Practice.
- Immediately taking precautionary action at least in accordance with Company's Well Control Procedures if an unexpectedly high-pressure formation is encountered and notifying Company immediately.

2.0 SCOPE OF WORK/SERVICE REQUIREMENT

CALL-OUT CONTRACT FOR CONVENTIONAL CORE HANDLING AND ANALYSIS FOR LAND OPERATIONS

 Contractor shall provide core handling equipment and services; Core preservation by resination, foam injection or wax presentation, Core cleaning, Gamma Ray Measurement, core marking, core plugging and plug preservation on site. Contractor shall be responsible for Storage of Core Samples and must demonstrate capability to do so effectively.

- Contractor Shall provide Equipment and Laboratory Services for Routine Core Analysis (Core gamma spectroscopy, Laboratory core plugging, dean stack cleaning of plugs, core slabbing, Porosity and Permeability measurements) and Special Core Analysis (FVF, water saturation wettability, waterflood susceptibility etc)
- Contractor shall have adequate personnel with adequate experience/capacity to carry out the different Core Services from Core Handling to Core Analysis.

3.0 MANDATORY REQUIREMENTS

- a. To be eligible for this exercise, interested Tenderers are required to be pre-qualified and 'live' in the SLICKLINE SERVICES category in NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified suppliers in this category will receive a Technical Invitation to Tender (ITT).

- c. If you are not listed in a product/service category, but you are registered with NUPRC to do business, contact NipeX office at 8 Bayo Kuku Road, Ikoyi, Lagos. with your NUPRC certificate as evidence for verification and necessary update.
- d. To initiate the JQS pre-qualification process, access http://vendors.nipex-ng.com to download the application form, make necessary payments and contact NipeX office for further action.
- e. To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

NIGERIAN CONTENT DEVELOPMENT:

Tenderers shall be expected by the Nigerian Content Development Monitoring Board (NCDMB) to:

- a. Furnish details of company ownership and shareholding structure. Also submit photocopies of its CAC Forms CO2 and CO7.
- b. Provide detailed description of the location of incountry facilities (office, storage, workshops)
- c. Minimum 50% equity ownership of asset & equipment to be deployed for this work scope.
- d. Tenderers to provide evidence of category C NCEC for in-country ownership of the relevant equipment to execute s scope of work.
- e. In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered



trainer(s) or other approved NCDMB training institution(s).

f. Evidence of Registration on the NCDMB NOGIC JQS Portal.

4.0 NIGERIAN CONTENT

Tenderers are to note that they will be requested during the technical tender to give full details of their relevant strategy to ensure that they fully comply with the Nigerian Oil & Gas Industry Content Development (NOGICD) Act, 2010 as non-compliance will constitute a FATAL FLAW in all tender evaluations. In line with the above, Tenderers will be required to ensure that information on the following, among others, is included in their technical submission:

- a. Demonstrate that the entity is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work. Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies including evidence or plans of physical operational presence and set-up in Nigeria
- b. International or multinational companies working through a Nigerian subsidiary must demonstrate that a minimum 50% of equipment to be deployed for execution of work shall be owned by the Nigerian subsidiary by providing a list of equipment for this tender and indicating those that will be owned by the Nigerian subsidiary



- c. Furnish details of company ownership and shareholding structure. Also submit clear photocopies of CAC Forms CO2 and CO7
- d. Provide evidence of what percentage of key management positions are held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- e. Provide a Nigerian Content Plan providing a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that would be involved in executing the work. Also provide details of Nigerian Content focal point or manager.
- f. State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidences of well-equipped offices and workshop; attach past experience of such patronage.
- g. Specific to this project, provide detailed plan for human capacity building of the National skill pool on the project-specific courses as stated in the ITT (including all software to be used, number of personnel, name of organization providing such training and evidence of past training record) for Nigerian personnel including description of any specific programs in place for transfer of technology and skills to indigenous businesses and Nigerians over the next five (5) years.

5.0 CLOSING DATE

Only tenderers who are registered with NJQS in the Product/Service category Code 3.04.10 as at 1700hrs on 4th March 2022 being the advert closing date shall be invited to submit Technical Bids.
