**1.0 INTRODUCTION**

Newcross Exploration and Production (Nigeria) Limited, Operator of NNPC/Newcross E&P Joint Venture in OML-24, located offshore in Rivers states, (referred to in this publication as "Insured") hereby invites suitable and reputable vendors to apply for the provision of dredging services at Ekulama 1 & 2, and Awoba flowstations/fields, with an anticipated contract term of two (2) years with optional one (1) year extension. Contract is expected to commence in 2018.

**2.0 SCOPE OF WORK**

The Contractors shall provide capital and maintenance dredging services for the Company's flowstation locations at Ekulama 1& 2 and Awoba fields. The scope of work/ services shall include but not limited to:

- a. Pre and Post Dredged Survey for construction works.
- b. Soil Investigation and Sand search.
- c. Construction and maintenance of bund wall to contain dredged spoils.
- d. Reclamation works and sand stockpile.
- e. Dredging works for old and new wells slots.
- f. Dredging of access canal.
- g. Clearing of silted swamp route used during operations.
- h. Floatation dredging using Grab crane and Suction cutter dredging of the required access/ slot area.

**3.0 MANDATORY REQUIREMENTS**

To be eligible for this tender exercise, interested Contractors are required to be prequalified in the **3.06.05 Dredging Services Product Category** in NipeX Joint Qualification Scheme (NJQS) database. Ensure this is done by the Advert close date. **All successfully prequalified Suppliers in this category will receive Invitation to Technical Tender (ITT).**

- e. To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

**F. NIGERIAN CONTENT DEVELOPMENT STRATEGY**

In consonance with Nigerian Oil & Gas Industry Content Development Act, Newcross Exploration and Production Nigeria is committed to providing opportunities for indigenous Nigerian capacity development and utilization. In pursuant of the aforementioned, the prospective bidders must therefore, comply/ submit at the ITT stage the following:

- a. Provision of detailed description of all work bidders will accomplish using Nigerian Resources (Labour, Materials & Services).
- b. Provision of current and in-place organization structure with detailed experience and skills of key management personnel with names. Provide evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerians Nationals and the percentage of total workforce that are Nigerians.
- c. Detailed past experienced/present commitment to staff training and development of Nigerians personnel. Furnish details of training plans for Nigerians specific to this scope of work.
- d. Nigerians content plan with detailed description of the role, work-scope, man-hour and responsibilities of all Nigerians companies and personnel that are involved in executing the service.
- e. State any further innovation proposals that would enhance the development of Nigerian content for the project.
- f. Demonstrate that entity is a Nigerian company as defined in the NOGICD Act 2010. Where capacity is inadequate, genuine alliance with multinationals companies for the purpose of technology transfer will be accepted; the alliance or joint ventures will demonstrate with binding memorandum of agreement signed by chief executive of the entity that evidences clear work-share ratio among the parties and time frame for growth or transfer to be achieved.
- g. Details of company ownership and shareholding structure with certified true copies of CAC forms CO2 and CO7, including company memorandum and article of association and other evidence of entity's incorporation.
- h. Demonstrate evidence of having obtained Nigerian Content Equipment Certification (NCEC) from NCDMB for all the equipment to be deployed in the execution of the contract.
- i. The successful contractor will be adjudged on its commitment to comply with the NIGERIAN LOCAL CONTENT requirements within optimal and practical use of Nigerian resources on the project.
- j. Only indigenous companies can participate in this bidding exercise.

**g. CLOSE DATE**

Only tenderers who are registered with **NJQS Product/Category 3.06.05-Dredging Services for Ekulama 1 & 2, and Awoba Flowstation**, as at **June 26, 2018** being the advert close date shall be invited to submit Technical Bids.
