### 1.0 INTRODUCTION

Newcross Exploration and Production Company Limited, on behalf of NNPC/NewcrossEP Joint Venture hereby invites competent and qualified contractor with suitable equipment and relevant experience for the provision of Drilling Bits (Rock and PDC) and Engineering Services. The proposed contract will commence from Q2 2019 and remain active for two (2) years firm duration with extension option duration of one (1) year. ### 2.0 SCOPE OF WORK/SERVICE REQUIREMENT

The scope of work under the tender comprises the provision of Drilling Bits & Engineering Services activities in Well Construction operations.

Details of the scope include:

1. To provide both rock and monoblock drilling bits
2. Comprehensive bit proposals for each hole section on request
3. High quality engineering support; inspection, maintenance and repair of drilling bits; Warehousing and stock management services for bits and accessories.
4. Contractor shall be required to carry out rock integrity/compaction analysis from time to time in bid to recommending optimized performance of recommended bits as the contract period progresses.

Supply shall be on consignment basis

### 3.0 MANDATORY REQUIREMENTS

- 4.0 • To be eligible for this tender exercise, interested contractors are required to be pre-qualified in the 1.01.09 **Drilling Bits category** of the NipeX Joint Qualification (NJQS) Database. All successfully pre-qualified suppliers in this category will receive Invitation to Technical Tender (ITT).

- 6.0 • If you are not listed in a product/service category you are registered with DPR to do business, contact NipeX office at 8, Bayo Kuku Street, Ikoyi Lagos with your DPR certificate as evidence for verification and necessary update.
- 7.0 • To initiate the JQS pre-qualification process, access [www.nipex-ng.com](http://www.nipex-ng.com), click on services tab followed by NJQS registration.
- 8.0 • To be eligible, all tenderers must comply with the requirements of the Nigerian Content requirements in the NipeX system

### 9.0 NIGERIAN CONTENT

Bidders are invited to express complete understanding and willingness to develop in-country capability and capacity for related work packages in compliance with the Nigerian Oil and Gas Industry Content Development Act (NOGICD, 2010) and Cabotage Act.

Pursuant to the above, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act, only bidders' whose submissions are in compliance shall proceed to the next stage of the tender process.

The information/documentation that will be required to be submitted by bidders at the ITT stage among others are as follows:

1. Provide a detailed and signed Nigerian Content Execution Plan describing how tender intends to comply with the Nigerian content requirements of the role, Scope of Work, and responsibilities of all Nigerian companies and Personnel that would be involved in executing this work.

### 10.0 CLOSING DATE

Only tenderers who are registered with NJQS Product/Category **1.01.09 – Drilling Bits** as at 1700hrs on **4<sup>th</sup> September, 2018** being the advert close date shall be invited to submit Technical Bids.

### 11.0 ADDITIONAL INFORMATION

This advertisement of "Tender Opportunity" shall not be construed as a commitment on the part of NewcrossEP, nor shall it entitle Applicants to make any claims whatsoever and/or seek any indemnity from NewcrossEP and/or any of its Partners by virtue of such Applicants having responded to this Advert. 2. Tenderer shall demonstrate that bidding entity is a Nigerian registered Company or Indigenous Company with the provision of the following, 1. CAC registration Form (CO2 & CO7), 2. Evidence of registration with NCDMB NOGIC JQS.
3. Tenderer shall demonstrate in country capability by providing Detailed description of the location of in-country committed facilities & infrastructure (assets, technical office, and administrative space, storage, workshop, assembly area, laboratory in Nigeria Evidence of registered office address in Nigeria with physical addresses not P.O. Box
4. Tenderer shall provide evidence of 50% ownership of all equipment to be deployed to execute this work scope by submitting purchase receipt, bill of laden etc of such equipment. They include but not limited to Filtration package to consist amongst others DE Filter unit, dual pot cartridge filter unit, centrifugal pump skid, discharge and suction hoses and turndiameter, High pressure pumps BOP, Crossovers, Safety Joint, Hydraulic Jar, etc. that will be used for this service
5. In-line with NCEC guidelines (specific to tender), tenderer shall provide a valid category C Nigerian Content Equipment Certificate (NCEC) of all equipment that will be deployed for this service
6. Provide Corporate organizational and project/contract specific organogram with names and nationality of all personnel but not limited to Filtration supervisor, filtration operator, Tank Cleaning supervisor, Tank Cleaning Operator etc. and CV's of all personnel listed in the project organogram.
7. In line with NCDMB Human Capacity Development (HCD) guidelines, provided a detailed training Plan for Nigerians from the NCDMB data base to bridge the skills gap specific to the work scope and also evidence of MOA with OGTAN registered trainer to perform the classroom training.
8. Tenderer shall submit a procurement plan on how it will give first consideration to all consumables that can be sourced in-country from Nigerian subcontractors with evidence of MOA from whom such are procured from. A list with the main goods, materials or consumables that are planned to be used in the Contract. This list should differentiate consumables, goods, products, tools and equipment to be procured and used in the execution of the services inside of Nigeria and Outside of Nigeria
9. Research and Development (R & D): - R&D shall be carried out on the contract under the auspices of NCDMB approved R&D cluster. Tenderer shall submit a signed MOA with any of the NCDMB approved research clusters indicating how the cluster will be used and the area of research relevant to the contract. Tenderer shall develop, SCOPE (list areas of research, linkage to industry, key drivers and expected outcome), provide name of research cluster and Nigerian location of centres, R&D duration, value of R&D expenditure as a percentage of contract value, Tenderer's R&D PLAN shall, (list purpose, NC targets, milestones and deliverables, performance reporting and period).

All bidders tendering for this service should know that " Land and Swamp operations are exclusively for Nigerian indigenous service companies that have a minimum of 51% equity shareholding"

NOTE: Bidders shall be requested to provide evidences to show their compliance with the above listed requirements at the ITT stage. Failure to meet the Nigerian Content requirements is a 'FATAL FLAW.'
