## TENDER OPPORTUNITY: CALL-OFF CONTRACT FOR CEMENTING EQUIPMENT, MATERIAL AND ENGINEERING SERVICES

#### 1. INTRODUCTION

Pan Ocean Oil Corporation (Nigeria) Limited (herein referred to as Pan Ocean), Operator of NNPC/Pan Ocean Joint Venture in OML-98, located onshore in Edo and Delta states, requires the services of competent and qualified contractor with suitable equipment and relevant experience for the provision of Cementing Equipment (Pumping Included), Materials and Engineering Services.

#### 2. SCOPE OF WORK/SERVICE REQUIREMENTS

The scope of work is to carry out primary and remedial cementing operations required in the well delivery process, and have been categorized into the following:

- Cementing and pumping services for Primary Cementation, Remedial Cementation, top job, plug job, acid job, pressure testing, foam cementation and nitrified spacer job.
- Cement mixing and pumping equipment, suitable for onshore rig installation, rated to 10,000 psi.
- Nitrogen and mixing/pumping equipment for nitrified spacer foam cementation
- Contingency liner hanger, running tools and running services.
- Oilfield class G cement and chemical additives
- Recording and real-time display of mixing/pumping operations parameters
- Ball/dart launching head for top drives, and subsea launch mandrels suitable for subsea cementing and liner cementations
- Suitable casing circulating heads, Retrievable packers with storm choke valves, drillable cement retainers, retrievable bridge plugs, with wireline and drill pipe running kits
- Casing accessories float shoes and collars, centralizers, wiper plugs, plug sets, etc
- Cement and cement slurry testing services
- Preparation of cementing programmes and post-job cementing reports
- Onshore storage of cement chemical and additives, float equipment, packers and retainers
- Onshore bulk cement storage facility and capability to transfer bulk cement to supply vessels
- Qualified and competent personnel to run the cement units on the rigs.
- Suitable onshore storage and logistics in support of the above operations.

- Provide information on training of Nigerian employee and company plan for technology transfer.
- Submit an organizational structure to substantiate the information and address of location.
- Provide information of in-country facilities.
- Explain further innovative proposals that would enhance and sustain Nigerian Content on this project.
- Provide what other information, innovation or plans you have that will increase Nigerian content development in the contract.
- The successful contractor will be adjudged on its commitment to comply with the NIGERIAN LOCAL CONTENT requirements within optimal and practical use of Nigerian resources on the project.
- Demonstrate evidence of having obtained Nigerian Content Equipment Certification (NCEC) from NCDMB for all the equipment to be deployed in the execution of the contract.
- Only Nigerian indigenous service companies having verifiable Nigerian equity shareholding of 51% and above shall submit bid for this tender
- Tenderer to provide evidence of CAC Forms C02 and C07 including details of company ownership structure and level of equity participation of Nigerian shareholdings.
- Tenderer to provide evidence of 50% Nigerian ownership of equipment to be deployed for executing the project.
- Provide MOA with Oil & Gas trainers association (OGTAN) registered facility for both class room type (theoretical) and on-the-job training attachment for the duration of the project.
- Tenderer to provide list of all sub-contractors, vendors and third party service providers where equipment, materials, goods and services of Nigerian origin that shall be locally sourced on the project.
