4.0 NIGERIAN CONTENT REQUIREMENTS

Bidders are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and also comply with the following requirements:

- Provide evidence of company Ownership Structure form CO2 and CO7, registration on NOGIC NJQS and DPR certificate.
- Location of in-country facilities (engineering office, equipment, storage, workshops, repair & maintenance facilities and, testing facilities, fabrication yard, jetty)
- Provide project-specific training, man-hour budget, skill development and technology transfer plan for Nigerian personnel or indigenous business training and development for Nigerian nationals & indigenous business.
- The project shall domicile min. of 80% project management man-hours in Nigeria through the utilization of resources of Nigerian origin.
- The project shall domicile minimum of 80% engineering man-hours in Nigeria through the utilization of engineering service companies having practicing license of COREN.
- All fabrication shall be done 100% in country.
- Bidders shall give first consideration to local manufacturers with valid NCEC for all procurement items.
- All vessels to be used shall be Nigerian owned and categorised under vendor category A/AA/AAA in the NCDMB NOGIC NJQS categorization.
- Project shall procure in Nigeria ALL 3rd party services locally or carry out the procurement of services through vendors with valid Nigerian Content Equipment Certifications (NCEC) for the service category
