- Flow station emergency (piping & structural) repairs

- In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

- Submit Tenderer's corporate organizational and project/contract specific organogram. CV's of all personnel (as required by the Client and the service) listed in the project organogram should be submitted.
- Provide evidence of at least 50% Nigerian ownership of equipment not limited to Cranes, Trailer, Diesel Four, Wheel (4 W/D) Truck, Side Boom Crane, Welding Machine, Flush Pump, NDE Facility & Accessories etc. and others as stated in the scope of work.
- Provide Category C NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) issued by Nigerian Content Development and Monitoring Board in respect of the mentioned equipment.
- Provide MOA with in-country facility with category A NCEC for line pipe coating, procurement of line pipe (if required), NDE services etc.
