- Tenderer shall demonstrate how it intends to achieve 90% engineering man-hours in-country.
- The Tenderer shall provide valid evidence of registration of her engineering company by COREN.
- In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s)
- Tenderer shall demonstrate compliance with the Nigerian Labour clause during executing of the Work scope.
