#### 4.0 NIGERIAN CONTENT REQUIREMENTS

Tenderers are to note that they will be requested during the technical tender to give full details of their relevant strategy to ensure that they fully comply with the Nigerian Oil & Gas Industry Content Development (NOGICD) Act, 2010 as non-compliance will constitute a **FATAL FLAW** in all tender evaluations. In line with the above, Tenderers will be required to ensure that information on the following, among others, is included in their technical submission:

- Demonstrate that the entity is a Nigerian registered company, or Nigerian registered company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work. Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies including evidence or plans of physical operational presence and set-up in Nigeria
- Nigerian Indigenous company executing the work scope in alliance with foreign companies and multinationals should ensure that:
- the foreign company or multinational is duly registered in Nigeria;
- they submit CAC forms CO2 and CO7 of the both companies
- they submit binding memorandum of agreement (MOA) stating the following:
- i) The Nigerian indigenous company will be the lead of the partnership
- ii) The detailed scope of work to be performed by each party
- iii) Detailed personnel and equipment that each party will deploy to execute the work scope
- iv) The MOA will be governed by the laws of the Federal Republic of Nigeria
- v) The MOA to be signed by the Managing Directors of both companies.
- International or multinational companies working through a Nigerian subsidiary must
  - 1 Demonstrate that the Nigerian subsidiary has 51% and above Nigerian equity shareholding in the ownership structure of the legal registered entity of tenderer in Nigeria and duly registered on the NCDMB NOGIC JQS as service providers under the applicable and relevant product category
  - .2 Demonstrate that a minimum 50% of equipment to be deployed for execution of work shall be owned by the Nigerian subsidiary by providing a list of equipment for this tender and indicating those that will be owned by the Nigerian subsidiary
- Furnish details of company ownership and share holding structure. Also submit clear photocopies of your CAC Forms CO2 and CO7
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians.
   Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Provide a Nigerian Content Plan providing a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and
  personnel that would be involved in executing the work. Also provide details of Nigerian Content focal point or manager.
- State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names
  and addresses including evidences of well equipped offices and workshop; attach past experience of such patronage.
- Provide the Nigerian Content Equipment Certificate NCEC for equipment.
- Demonstrate plan that the company has legal, insurance and banking operations with Nigerian firms.
- Human Capital Development: Tenderers plan and strategy for human capacity development training on this tender shall comply with 10% of project hours as HCD training hours or 2% of total contract cost whichever is greater. The number of trainees shall be determined in accordance with NCDMB HCD training guidelines 2014 and the service of OGTAN registration and the training modules.
- Provide Evidence of MOA with the relevant research clusters. The MOA shall indicate how the service company intends to use the relevant research
  clusters during project execution to the satisfaction of the Board. Researchers that meet the technical requirements of the Board shall be notified on the
  Research Cluster they belong to: and they will be required to upload research proposals relevant to their cluster unto the NOGIC JQS portal
  (http://www.nogiciqs.com) on request
- Provide details on any other Nigerian Content initiative your company is involved in.
