## 1.0 INTRODUCTION

## 2.0 SCOPE OF WORK

The WORK to be covered under this CONTRACT generally consists of all works incidental and necessary for the successful completion of services related to the Provision of Roads and Location Preparation Works and shall include the following:

#### **Major Category**

Rehabilitation and reconstruction of roads in seasonally flooded swampy areas, new construction of access/field roads and location preparation works directly associated with the short-term drilling and workover sequence, bridge construction and rehabilitation consisting of the following activities:

- Survey
- Site Clearing and Earthworks
- Cement stabilization
- Laying of base course
- Flexible pavement and surface works (Asphalt, surface dressing etc)
- Piling works
- Reinforced concrete works for cellar pits and slabs, generator slab, waste pit etc
- Reinforced concrete works for rigid pavement & road construction
- Construction of drainage
- Fencing works
- Bridge construction and rehabilitation

# **Medium Category**

Repairs and rehabilitation of existing company access/field roads and locations in the dry land area consisting of the following activities:

- Laying of base course

- Repair of existing location concrete for cellar structures, fence, drainage, septic tank etc.
- Restoration of decommissioned and abandoned borrow pits.

- 5. To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

## 4.0 NIGERIAN CONTENT REQUIREMENTS

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and provide the following requirements:

- Demonstrate that entity is a Nigerian registered company with greater than 51% Nigerian shareholding. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc.) including company memorandum & article of association and/or evidence of entity's incorporation, shareholding & ownership structure in Nigeria.
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Provide a Nigerian Content Execution Plan providing a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that would be involved in executing the work. Also provide details of Nigerian Content focal point or manager.
- State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidence of well-equipped offices and workshop; attach experience of such patronage.
- Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific
  training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved
  NCDMB training institution(s).
- In line with the latest NCDMB NCEC approved guideline, SPDC shall ensure first consideration is given to vendors with NCEC Category 1 & 2 in that order in the Construction and Movable Equipment. (EC)
- Provide evidence of domiciliation of project management and procurement centres in Nigeria with physical addresses (not P.O. Box).
- Location of in-country facilities (equipment, storage, workshops, repair & maintenance facilities and, testing facilities).
