- To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

## • 4.0 Nigerian Content Requirements

- Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and also provide the following requirements:
- Demonstrate that the entity is a Nigerian Registered Company, or Nigerian Registered Company as the
  contracting entity in genuine alliance or joint venture with foreign company with details on scope and
  responsibilities of parties for this work. Such companies must show evidence of joint venture binding
  agreement duly signed by the CEO of both companies including evidence or plans of physical operational
  presence and set-up in Nigeria
- Bidders shall demonstrate:
  - ➤ Evidence of registration with Manufacturers association of Nigeria

- ➤ Evidence of Nigerian Automotive council
- ➤ Evidence of registration with Ministry of commerce and industry
- Furnish details of company ownership and shareholding structure. Also submit clear photocopies of your CAC Forms CO2 and CO7
- Provide evidence of what percentage of your key management positions is held by Nigerians and what
  percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in
  Nigeria and those by Nigerian resources relative to total work volume.
- Specific to this work, provide detailed plan for training of Nigerian personnel and development on repairs & maintenance of vehicles in accordance with the NCDMB HCD.
  - Location of in-country facilities for manufacturing/ assemblage of vehicles in Nigeria or provide MOA with in-country manufacturer/ assemblage facilities for the procurement of vehicles in Nigeria.
