#### 1. INTRODUCTION:

The estimated primary duration of this contract is two (02) years with an option to extend it for another one (01) year.

#### 2. SCOPE OF WORK/SERVICE REQUIREMENTS:

#### Provision of Cementing & Pumping Services (Tender No. 1000004706) CATEGORY: 3.04.03 (Cementing Services, Cement Engineering)

Bidder shall supply cementing and pumping services including but not limited to cement slurry design, supply of cement and cement additives, provision for cementing Equipments such as silos, compressors, mixing equipment, batch mixers, cement pumping unit, dumb iron etc to perform primary, secondary, remedial cement jobs. Bidder shall provide pumping equipment for circulation during well control operation. Bidder shall have facilities of lab testing for cement slurry and water sample, capable of design and develop cement programme.
