TENDER OPPORTUNITY: PROVISION OF RIG AND DRILLING ANCILLIARY SERVICES FOR WESTERN ASSETS – OMLs 4,38 AND 41

1.0 INTRODUCTION:

Seplat West Limited, licensee of the Oil Mining Leases 4, 38 and 41 assets which is operated by the joint venture of Seplat Petroleum Development Company PLC and the Nigerian Petroleum Development Company Limited (NPDC/SEPLAT joint venture), invites interested and pre-qualified contractors to respond to these tender opportunities for the provision of the following services as detailed in item 2 below for OMLs 4, 38 and 41 assets. The contracts are proposed to commence in Q1, 2021 and continue for a duration of two (2) years with NPDC/SEPLAT Joint Venture having the sole option to extend the duration for a further period of one (1) year.

- Tenderers shall submit a procurement plan on how they will give first consideration to all consumables that can be sourced in-country from Nigerian subcontractors from whom such are procured from, with evidence of binding agreements. A list with the main goods, materials or consumables that are planned to be used in the contract. This list should differentiate consumables, goods, products, tools and equipment to be procured and used in the execution of the services within and outside Nigeria.

SEPLAT shall download Bidders' List from NIPEX PORTAL for Companies who are pre-qualified and LIVE in relevant NJQS Product/Services Codes indicated in 2.0 above as at **15:00 hours on 2nd of September 2020**, being the advert closing date.

Thereafter, a competitive bidding process shall be adopted. Invitation To Tender (ITT) shall be issued for both Technical and Commercial tenders to the approved bidders. Bidders shall upload bid documents (technical and commercial) on Nipex portal.
