To determine if you are pre-qualified and view the product/service category you are listed for, open<u>www.nipex-ng.com</u> or <u>www.nipexnig.com</u> and access NJQS with your login details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click supplier product group.
- 3. If you are not listed in a product/service category you are registered with DPR to do business, contact NipeX office at 30, Oyinkan Abayomi Street, Ikoyi, Lagos with your DPR certificate as evidence for verification and necessary update.
- 4. To initiate the JQS prequalification process, access www.nipex-ng.com or www.nipexnig.com to download the application form, make necessary payments and contact NipeX office for further action.
- 5. To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

4.0 NIGERIAN CONTENT REQUIREMENTS

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and also provide the following requirements:

- All tenderers shall during the stage 1 bidding demonstrate evidence of their registration as a service company for the applicable product category on the NOGIC JQS portal of NCDMB.
- Provide evidence of an enforceable MOA with local training service provider for the provision of training services in specific technical disciplines involved in the project.
- Provide evidence of approved Nigerian content equipment certificate or status of the application submitted to NCDMB for the
 procurement of all equipment, systems and packages to be supplied on the contract.
- Tenderer shall submit a signed MOA with any of the NCDMB approved research clusters indicating how the cluster will be used and the area of research relevant to the contract.
- Provide a project specific training plan for Nigerian nationals to be selected from a national database on the NOGIC JQS, manhour budget, skill development and technology transfer plan for Nigerian personnel.
- Provide a comprehensive technical training and development plan for the development of skills and competence amongst local labour hired for the work.
- Only Nigerian Indigenous company having at least 51% Nigerian equity shareholding in the ownership structure of the legal registered entity of the tender in Nigeria is allowed to bid for this work scope.
- Provide evidence of MOA and NCEC with local manufactures and OEM representatives in-country
- Human Capacity Development -Tenderer shall execute HCD training for Nigerian nationals which shall be fully inclusive of all costs associated with delivering 10% of total project hours (minimum of 5,000 man-hours annually) as HCD training hours or 3% of total contract cost whichever is greater. The number of trainees shall be determined in accordance with NCDMB HCD training guidelines and training duration shall be minimum of one year.
- Evidence to domicile at least 80% of Project management and procurement centre in Nigeria with Current in-Country committed facilities and Infrastructure (warehouse, office and workshop)
- Provide evidence of COREN registration (Corporate and Personnel) or binding Memorandum of Agreement (MOA) with COREN registered company to perform detailed engineering

5.0 CLOSING DATE: Only Tenderers who are registered in the NJQS product/category **1.10.01 or** 4.04.09 **or** 4.05.09 **as at April 8 2017** being the advert close date shall be invited to submit Technical bids.

6.0 ADDITIONAL INFORMATION

- The contract shall be awarded to two (2) successful contractors on lump sum basis.
