1.0 INTRODUCTION

Remediation activities in Bodo creek will require special consultancy services to achieve the objectives of reduction of the level of contaminants of concern (CoC) in the soil/sediments to the level that promotes net environmental benefit, and ensure that the remediation processes support the re-generation of sensitive mangrove vegetation and support replenishment of aquatic fauna.

The work is planned to commence in October 2018 and will last for 18 calendar months.

SHELL hereby announces to interested and prequalified companies an upcoming tendering opportunity for the provision of consultancy services for remediation project of crude oil impacted area in Bodo creek, Ogoniland, Rivers State, Nigeria for SPDC. The proposed contract will commence in October 2018 and remain active for 18 months duration, followed by 6 months option.

2.0 SCOPE OF WORK

The scope of activities to be covered shall include but not limited to the under listed in connection with Consultancy services for Remediation works in Bodo creek, located Ogoniland Nigeria: The scope of works covers the following:

- 1. Development of sampling protocol, involving determination of sampling points and sampling profiles.
- 2. Design, development and installation of monitoring boreholes
- 3. Soil testing for geotechnical and hydrogeological parameters such as permeability or hydraulic conductivity.
- 4. Chemical testing of constituents of concern (CoC)
- 5. Land and marine logistics

- 3. If you are not listed in a product/service category and you are registered with DPR to do business, contact NipeX office at 8/10 Bayo Kuku Road Ikoyi with your DPR certificate as evidence for verification and necessary update.
- 4. To initiate the JQS prequalification process, access www.nipex-ng.com, click on services tab followed by NJQS registration.
- 5. To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

4.0 NIGERIAN CONTENT REQUIREMENTS

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and provide the following requirements:

• Demonstrate that the entity is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties

for this work. Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies including evidence or plans of physical operational presence and set-up in Nigeria

- International or multinational company working through a Nigerian subsidiary must demonstrate that a minimum of 50% of equipment to be deployed for execution of work shall be owned by the Nigerian subsidiary by providing a list of equipment for this tender and indicating those that will be owned by the Nigerian subsidiary
- Furnish details of company ownership and shareholding structure. Also submit clear photocopies of your CAC Forms CO2 and CO7
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Provide a Nigerian Content Plan providing a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that would be involved in executing the work. Also provide details of Nigerian Content focal point or manager.
- State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidences of well-equipped offices and workshop; attach past experience of such patronage.
- Specific to this work, provide detailed plan for staff training and development on equipment repairs & maintenance and procurement (including all software to be used, number of personnel, name of organization providing such training and evidence of past training record) for Nigerian personnel including description of any specific programs in place for transfer of technology and skills to indigenous businesses and Nigerians over the next five (5) years.
- Location of in-country facilities (Storage, workshops, repair & maintenance facilities and testing facilities)
- Contractor must be willing and able to provide evidence of maximization of made in Nigeria goods and services.
- Provide details on any other Nigerian Content initiative your company is involved in.

5.0 CLOSING DATE

Only Tenderers who are registered in the relevant NJQS product/category as at 31th July 2018 being the advert close date shall be invited to submit Technical and commercial bids.

6.0 ADDITIONAL INFORMATION

- All costs incurred in preparing and processing NJQS prequalification shall be to the contractor's accounts.
