

**TOTAL UPSTREAM NIGERIA LIMITED****TENDER OPPORTUNITY FOR OML 130: PROVISION OF ACCOMMODATION VESSEL (FLOTEL) SERVICES FOR AKPO 2018 FULL FIELD SHUTDOWN***NipeX Tender Ref: 100002263***1. Introduction**

Total Upstream Nigeria Limited (TUPNI) operator of the OML 130 issues tender opportunity to interested and reputable Contractors with requisite experience for consideration to tender for the Provision of Accommodation Vessel (FLOTEL) Services for Akpo 2018 Full Field Shutdown (FFSD) in its Deep Offshore OML130 operations.

2. Brief description of Work Scope and Specifications

The expected duration of this contract is two months commencing late Q3 in 2018.

The scope of work includes:

- Commissioning/Delivery to Charterer (TUPNI)
- Installation on site
- Connection/disconnection of the gangway to and from FPSO.
- Accommodation/Catering for passengers and crew
- Bunkering operation/ Supply operations
- Passengers change operations (by helicopter or crew boats)
- Decommissioning/Redelivery to contractor

The flotel shall have following characteristics:

- Provide accommodation/catering for 350 passengers and crew
- Have Dynamic Positioning (DP) Class 3
- Have a self-operating gangway for transfer of passengers from and to the FPSO on a permanent basis and under all operating conditions of the FPSO
- Have a lay-down area served by at least one cargo crane to be intended as buffer storage (goods/equipments/parts) for the FPSO
- Have a certified Helideck for thirteen (13) tones class helicopters (type S92) or equivalent.
- Have equipment enabling the transfer of crew/passengers from and to a crew boat.
- Be operated by a qualified crew and according to international maritime standards.
- Be classed with a society member of IACS (International Association of Classification Society)
- Have necessary equipment for communication with the FPSO
- 2 Cranes 20tonnes @ 20 m radius.

3. Mandatory Requirements

- a. To be eligible for this tender exercise, interested Tenderers are required to be pre-qualified in the **3.08.04 Accommodation Platform / Vessels Services** categories in NipeX Joint Qualification System (NJQS) database. All successfully prequalified suppliers in this category will receive Invitation to Tender (ITT).
- b. To determine if you are pre-qualified and view the product/services category you are listed for: Open <http://vendors.nipexjqs.com> and access NJQS with your log in details. Click on Products/Services Status tab to view your status and product codes.
- c. If you are not listed in a product/service category that you are registered with at DPR to do business, you may contact NipeX' office at 30, Oyinkan Abayomi Street, Ikoyi, Lagos, with your DPR certificate as evidence for verification and necessary update.
- d. To initiate the JQS Pre-qualification process, you may access www.nipex-ng.com click on services tab followed by NJQS registration.
- e. To be eligible all Tenderers shall also be required to comply with the Nigerian Content requirements in the NipeX system.

4. Nigerian Content

TUPNI is committed to the development of the Nigerian Oil and gas business in compliance with the Nigerian Content Act 2010 for Nigerian Content Development.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian oil and gas industry shall be consistent with the level set in the Schedule of the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (The Board)

Tenderer(s) shall comply with all the provisions of the Nigerian Content Act that relate to this advert and in particular comply with the minimum Nigerian Content percentage for the scopes which are covered in the Schedule of the Act. This also includes and any other requirement that may arise from time to time not explicitly stated in this advert but which apply to the services in fulfillment of the Nigerian Content Act, in the submission of their Tender.

Failure to fully comply with the Nigerian Content Act or demonstrate commitment to Nigerian Content Development Policy of the Nigerian government shall result in the disqualification of the tenderer from the bidding process.

Only Nigerian indigenous service companies having verifiable Nigerian equity shareholding of 51% and above shall submit bids for this tender.

As part of their submissions, Tenderer shall:

- a.) Tenderer shall provide copies of CAC registration forms CO2 & CO7 and provide details of your corporate ownership structure in percentages showing the percentage of Nigerian shareholders and also provide evidence of registration and latest NCDMB NOGIC Marine Vessel Categorization Report limited only Category A/AA Vendors with Accommodation Vessels or flotel in their fleet on the NCDMB JQS
- b.) Tenderer shall demonstrate evidence of Nigerian ownership of the Marine vessels (Accommodation vessel or similar product/service category). Tenderer shall be duly categorized as A/AA on the NCDMB NOGIC JQS marine vessel categorization in applicable product/service category or providing MOA with category A/AA vendor (not bidding for this tender) on the NCDMB NOGIC marine vessel categorization who can demonstrate Nigerian ownership of the nominated vessel in the applicable product/service category.
- c.) Tenderer shall demonstrate in accordance with the NOGICD Act (and consistent with the Cabotage Act), a minimum of 80% Nigerian crewing and manning on-board the vessels. The nationality of the crew dependent of the vessel type, Intermediate and junior staff = 100% nationals –able sea man, cook, steward, 3rd engineer etc. More specialized position with expatriates must be backed up with succession plan and evidence of commitment to obtaining expatriate quota before execution of work scope.
- d.) Tenderers to provide firm commitments with MOAs executed with proposed Nigerian indigenous service providers for the following on-board vessel services: Healthcare services, Cleaning and waste disposal services, emergency response services, security services, maintenance services, catering services, housekeeping and laundry services, Logistics services and petroleum product supply.
- e.) Tenderers to provide a description of contractor-specific training, skill development and understudy plan for Nigerian personnel in key areas. In line with NCDMB National Human Capacity Development Initiative, Tenderer to provide details on contract-specific training plan and man-hours for Nigerian Nationals.

NOTE: Failure to comply with the provision of the Nigerian Content Act 2010 or to demonstrate commitment to the development of the Nigerian Content Policy shall result in the disqualification of the tenderer from the bidding process.

5. Closing Date

Only suppliers, who are registered with **Accommodation Platform / Vessels Services (3.08.04)** and LIVE as at **22nd December, 2017**, being the advert closing date, shall be invited to submit technical tenders.

6. Additional Information

- a.) Failure to provide any of the listed documents or information may automatically disqualify the tenderer.
- b.) All costs incurred in registering and prequalifying for this and other service categories in NJQS shall be borne solely by the Contractors/suppliers.
- c.) This advertisement shall neither be construed as an invitation to Tender (ITT) nor a commitment on the part of TUPNI to award a contract to any supplier and/or associated companies, subcontractors or agents.
- d.) The ITT and any further progression of this tender shall be via NipeX. Interested bidders are therefore advised to ensure that their profiles in NipeX are active with a valid official email address accessible by their organization as this shall be the only means to transmit the ITT.
- e.) Tendering process will be the NNPC contracting process requiring pre-qualified companies to submit technical tender first. Following a technical review, only technically and financially qualified contractors will be requested to submit commercial tenders.
- f.) Man hour figures for Capital Project Portfolios are estimates to provide definition to the scope and do not constitute guaranteed quantities.
- g.) TUPNI will only recognize and correspond with duly authorized officers of the pre-qualified bidders and NOT through individuals or agents acting on their behalf.
- h.) Interested tenderer(s) should note that TUPNI has very cordial relationship with the host communities of the sites where these services will be performed based on existing Memorandum of Understanding (MOU). Prospective tenderer(s) will be required to implement the obligations of the MOU as part of their contract.
