## INTRODUCTION

1.

Total Exploration and Production Nigeria Limited (TEPNG) operator of the NNPC/TOTAL Joint venture, employs various Pressure Vessels on its Onshore Sites that require integrity checks in order to ensure that they are operating at optimum conditions and also to meet statutory regulatory requirements.

There are basic preparatory/cleaning processes that must be performed to ensure the Vessel's accessibility such as:

- Spading and Unspading
  Manhole Opening and Closing
  Removal and Reinstallation of Channel Heads
- Removal and Reinstallation of Tube Bundles
- Pressure Vessel Ventilation
- Confined Space Entry for Vessel Cleaning
- House Keeping and Site Restoration

These should be done in order to enable the scheduled integrity inspection checks on the Pressure Vessels to proceed.

#### 2. SCOPE OF WORK/DURATION

These Services are expected to commence during the 4th Quarter of 2018

The expected duration of the Services is two (2) years plus one (1) year optional extension period.

The scope of work consists of activities required and incidental to the provision of vessel cleaning services for OML58, preparatory to Non-Destructive Examination (NDE) by appointed third-party companies. This service shall involve, but not be limited to, the following activities:

- Scaffolding erection and dismantling
- Hot Bolting
- Spading, un-spading and Mechanical Isolation.
- De-sanding/sand jetting(if applicable)
  Opening, closing of Manholes and ventilation.
- Mechanical Cleaning and removal of sludge, debris and/or any other unwanted matter from the vessel.
- Assist site production team in process isolation and draining.
- Depleted anode and support removal and installation
- Insulation, lagging and personnel Protection removal and installation. Weld overlay, repairs of internal part and Internal coating/painting where required.
- Nitrogen purging and leak test where applicable.
- Provision of materials fasteners, gaskets, blind flanges etc required to re-assemble the vessels and make good all connections required to return the vessels to service as only a back-up materials.
- Provision of the personnel, equipment, tools, special tools where necessary and consumables to carry out the vessel cleaning tasks.
- Pneumatic Torqueing/Tensioning services during the vessel cleaning and preparation services according to COMPANY's 5 piece Tag flange management procedures.
- Application of protective coating, as specified, to the vessels and affected piping when necessary.
- Clean up of spillages, bagging, sealing and identifying waste in dedicated waste skips for correct disposal

#### 3. MANDATORY REQUIREMENTS

- a.) To be eligible for this tender exercise, interested contractors are required to be prequalified in the 3.05.22 (Sludge Treatment / Tank Cleaning Services) category in NipeX joint Qualification system (NJQS) database. All successfully pre-qualified suppliers in this category will receive an Invitation to Technical Tender (ITT).
- b.) To determine if you are pre-qualified and can view the product/service category you are listed for; Open http://vendors.nipexjqs.com and access NJQS with your log in details. Click on Products/Services Status tab to view your status and product codes.
- If you are not listed in a product/service category and you are registered with DPR to do business, contact NipeX office at 8/10 Bayo Kuku Street, Ikoyi, Lagos with your DPR c.) certificate as evidence for verification and necessary update.
- d.) To initiate the JQS pre-qualification process, access www.nipex-ng.com, click on services tab followed by NJQS registration.
- e.) To be eligible, all tenders must comply with the Nigerian content requirements in the NipeX system.

#### 4. NIGERIAN CONTENT

TEPNG is committed to the development of the Nigerian Oil and gas business in compliance with the Nigerian Content Act 2010 for Nigerian Content Development.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian oil and gas industry shall be consistent with the level set in the Schedule of the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (The Board)

Tenderer(s) shall comply with all the provisions of the Nigerian Content Act that relate to this advert and in particular comply with the minimum Nigerian Content percentage for the scopes which are covered in the Schedule of the Act. This also includes and any other requirement that may arise from time to time not explicitly stated in this advert but which apply to the service in fulfillment of the Nigerian Content Act, in the submission of their Tender.

Failure to fully comply with the Nigerian Content Act or demonstrate commitment to Nigerian Content Development Policy of the Nigerian government shall result in the disqualification of the tenderer from the bidding process.

### As part of their submissions. Tenderer shall:

a.) Develop a Nigerian Content Plan (NCP), which shall explain the methodology of how it intends to comply with the requirements of the Act and how to achieve the set target(s) in the Schedule of Nigerian Oil & Gas Industry Content Development Act and any targets set by The Board.

- b.) Develop a Research & Development Plan which shall explain the methodology of how it intends to promote education, attachments, training, research and development in Nigeria in relation to the contract.
- Develop an employment and training plan which shall explain how first considerations shall be given to employment and training of Nigerians in work programme on the contract, hiring and training needs with a breakdown of the skills needed and anticipated skill shortage in the Nigerian labour force including the training and understudy program for succession planning.
- d.) Submit a plan for how it intends to give first consideration to services provided from within Nigeria with a list of work packages, 3rd party services and subcontracts that should be reserved for Nigerian indigenous contractors and those for Community Contractors including the list of services that will be provided by companies of Nigerian origin.
- e.) Submit a plan for how it intends to give first consideration to raw materials and manufactured /assembled goods of Nigerian origin. This shall include a breakdown of all raw materials to be utilized and identify those that are found locally. Finished products and materials that will be procured from Nigerian Manufacturing & assembly plants; finished foreign goods that can be ordered by Nigeria through Nigerian authorized vendors and accredited agents and those that would be directly imported.
- Demonstrate that Tenderer's entity is a Nigerian-registered company. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc) including company memorandum & article of association and other evidence of entity's incorporation, f.) shareholding & ownership structure in Nigeria. Maximizing Nigerian Content is a key contract priority, therefore for foreign companies and multinationals in alliance with a local company, submit evidence that the local company is an indigenous company and the binding Agreement of the alliance duly signed Agreement by the CEO of both parties and stating the specific work scope to be performed by each member of the alliance. Tenderer shall demonstrate evidence of registration with NCDMB NOGIC JQS
- g.) Provide detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, technical office, and administrative space, storage, workshop, assembly area, repair & maintenance, testing, laboratory, etc) in Nigeria to support the future Services. Evidence that 50% of all equipment deployed to work by multinational and international companies is owned by the local subsidiaries is a necessity.
- h.) Provide a project-specific training, man-hour budget, skill development and technology transfer plan for Nigerian personnel or indigenous business including evidence of past performance on training and development for Nigerians nationals & indigenous business. Plan for sponsorship of Nigerians to acquire competence and/or certification. Further development of local employees as professionals. Proposed training plan for Nigerians on the project including a brief training outline for OEM products, engineering, software & hardware, project management, procurement, construction, installation, start-up & commissioning, maintenance, testing and operations.
- Provide evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerian Nationals and the percentage of the total i.) workforce that are Nigerians.
- Tenderer shall submit corporate organizational and project/contract specific organogram j.) demonstrating 100% Nigerian nationals as employees to execute service. The project organogram should include but not limited to the names and nationality of key personnel (obtain key personnel information from scope of work inside ITT document where applicable). CV's of all personnel listed in the project organogram should be submitted.
- k.) Tenderer shall demonstrate how it intends to carry out NDT, Scaffolding erection and dismantling, hot bolting, depleted anode & support removal & installation, pneumatic Torqueing/Tensioning, fabric renewal and procurement of consumable such as gaskets, blind flanges, etc
- Tenderer shall submit valid Nigerian Content Equipment Certificate (NCEC) applicable to 1.) this product/service category.
- m.) Demonstrate how 100% of the key personnel positions would be occupied by Nigerian national employees.

The tender is to be bidded for exclusively by only Nigerian indigenous companies.

NOTE: Failure to comply with the provision of the Nigerian Content Act 2010 or to demonstrate commitment to the development of the Nigerian Content Policy shall result in the disqualification of the tenderer from the bidding process.
