2. SCOPE OF WORK/DURATION

These Services are expected to commence during the 1st Quarter of 2018 The expected duration of the Services is three (3) years plus two (2) years optional extension period.

The scope of Services for the ICSS Maintenance Support Services Includes but not limited to :

- Development and input of all planned maintenance activities to the COMPANY's Computer Maintenance Management System (CMMS), UNISUP relating to CS3000/Foxboro IA/Triconex installed in all TEPNG production sites
- Management and follow-up of all ICSS jobs being done by a third party ICSS contractor/system Integrator
- Implementation, testing and commissioning of necessary modifications
- Training of young engineers
- Centum VP knowledge is an added advantage

3. MANDATORY REQUIREMENTS

- (b) To be eligible, all Tender's must have the OEM certification.

- Onshore activity: To be bidded for by only Nigerian indigenous company (g) having greater than or equal to 51% Nigerian shareholding.
- (h) Offshore activity: To be bidded for by Nigerian registered company

4. NIGERIAN CONTENT

TEPNG is committed to the development of the Nigerian Oil and gas business in compliance with the Nigerian Content Act 2010 for Nigerian Content Development.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian oil and gas industry shall be consistent with the level set in the Schedule of the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (The Board)

Tenderer(s) shall comply with all the provisions of the Nigerian Content Act that relate to this advert and in particular comply with the minimum Nigerian Content percentage for the scopes which are covered in the Schedule of the Act. This also includes and any other requirement that may arise from time to time not explicitly stated in this advert but which apply to the service in fulfillment of the Nigerian Content Act, in the submission of their Tender.

Failure to fully comply with the Nigerian Content Act or demonstrate commitment to Nigerian Content Development Policy of the Nigerian government shall result in the disgualification of the tenderer from the bidding process.

- Demonstrate that Tenderer's entity is a Nigerian-registered company. (f) Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc) including company memorandum & article of association and other evidence of entity's incorporation, shareholding & ownership structure in Nigeria. Maximizing Nigerian Content is a key contract priority, therefore for foreign companies and multinationals in alliance with a local company, submit evidence that the local company is an indigenous company and the binding Agreement of the alliance duly signed Agreement by the CEO of both parties and stating the specific work scope to be performed by each member of the alliance.
- (g) Provide detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, technical office, and administrative space, storage, workshop, assembly area, repair & maintenance, testing, laboratory, etc) in Nigeria to support the future Services. Evidence that 50% of all equipment deployed to work by multinational and international companies is owned by the local subsidiaries is a necessity.
- (h) Provide a project-specific training, man-hour budget, skill development and technology transfer plan for Nigerian personnel or indigenous business including evidence of past performance on training and development for Nigerians nationals & indigenous business. Plan for sponsorship of Nigerians to acquire competence and/or certification. Further development of local employees as professionals. Proposed training plan for Nigerians on the project including a brief training outline for OEM products, engineering, software & hardware, project management, procurement, construction, installation, start-up & commissioning, maintenance, testing and operations.
- (I) Provide evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerian Nationals and the percentage of the total workforce that are Nigerians.
- Submit Tenderer's corporate organization's overall human resources (j) structure (mgt, supervisors, senior & junior skilled officers, etc) identifying positions manned/occupied.
- (k) Submit verifiable evidence of the OEM's Nigerian Content Equipment Certificate (NCEC) issued by NCDMB during the technical phase of bidding.
- Demonstrate how 80% of the key personnel positions would be occupied (I) by Nigerian national employees.

The tender is to be bided for exclusively by only Nigerian indigenous companies.

NOTE: Failure to comply with the provision of the Nigerian Content Act 2010 or to demonstrate commitment to the development of the Nigerian Content Policy shall result in the disqualification of the tenderer from the bidding process.

5. CLOSING DATE

Only tenderers who are registered with 3.01.04 (Electro/Control Instrumentation Services) categories in NipeX joint Qualification system (NJQS) database as at this advert closing date shall be invited to submit Technical Bids. Close date of advert is 2/10/2017.

- (c) Develop a Technology Transfer Plan which shall explain the methodology of how it intends to promote the effective transfer of technologies from alliance partners to Nigerian individuals and companies.
