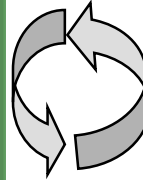

Accessing NipeX SAP-SRM 7.0

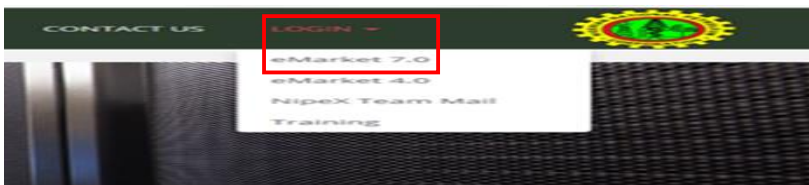
The SAP-SRM 7.0 PPS system is now live. It is expected to be available for commercial use in the first quarter of 2016.

How to Access NipeX SAP-SRM 7.0

There are two types of access to the system, the Anonymous access and secure area access. The anonymous access allows any member of the public to view tender opportunities in the industry, NJQS registration requirements and other generic information. Log in details are not required to access the **Anonymous areas**.

The secured area access requires User ID and Password to enable the User carry out contracting activities. The secure area is only accessible to companies registered in NipeX.

1. To access NipeX SAP-SRM 7.0, type **www.nipex-ng.com** on the address bar of the browser and click **go**. The NipeX home page opens
2. Click on LOGIN, from the drop down menu and choose eMarket 7.0



3. Please enter the e- Market log on details in the space provided



4. A new user must change the password on the first log on
5. If the log on is successful, the user gets in to the secure area of the NipeX e-Market 7.0

NOTE: Old tenders will still be transacted on the SAP-SRM 4.0

Product Code Addition

A: Mandatory documents for Product Code Addition

Kindly note that it is mandatory for the following documents to be attached to all Suppliers Product/Service Code Addition requests:

1. Relevant DPR permit (Acknowledgement slips will not be acceptable)
2. Work History for requested code(s)/service(s)
3. Memorandum of Agreement (MOA), if applicable
4. List of relevant Equipment(s) (owned or lease)
5. Statutory document from relevant authorities for requested code(s)/service(s) e.g. NIMASA, Recruiter's license, etc.
6. Memorandum and Articles of Association
7. Certificate of Incorporation

Product Code Addition cont'd

B: Important conditions to note:

1. Capability assessment based on approved product code addition will only be carried out during suppliers renewal audit (bi-annual). The approved codes will be categorized as 'D' until renewal audit is conducted
2. Exceptions to the above will only be applicable for special conditions/circumstances which will be treated on case by case basis

C: How to Request for Product Code Addition

1. Write a formal letter on your Company letter head paper to GM, NipeX requesting for all the relevant Products/Services code (s) you wish to add. Also attach the mandatory documents listed above for the Products/Services
2. Comprehensive details of the process for the various supplier status (Published, Suppliers under-going Audit and Pre-qualified) are available on the homepage of the NipeX portal: www.nipex-ng.com
3. NipeX will communicate the outcome of the Supplier/Company request via email
4. If the requested codes are accepted, the Supplier/Company will be informed of the applicable fees
5. If the requested codes are not approved, the Supplier/Company will be informed of the outcome
