## NipeX OPERATIONS: JQS & eMARKETPLACE

The Joint Qualification System (JQS) is designed to pre-qualify Suppliers registered in Nigeria. It increases efficiency and instills integrity in the pre-qualification process of the Nigerian oil and gas industry.



The eMarketplace is a collaborative environment that delivers significant value to all Stakeholders in the contracting process through a comprehensive suite of capabilities.

### **Highlights**

- . NipeX trained 157 Suppliers.
- 2. NipeX trained 53 Operators in the first quarter of 2016 on how to use the new SAP SRM 7.0.
- 3. Launched SAP 7.0 with NPDC Tenders and so far NipeX has on-boarded 20 tenders.
- Reviewed Product Codes for more effectiveness in the Oil and Gas industry;
   NipeX has reduced the number of product codes to 482 codes from 654 codes.
- NipeX has upgraded its London Data Center to twice its current capacity in terms of speed and storage capacity in order to boost NipeX's capacity to provide hosting services.
- Engaged NCDMB for more effective implementation of the NCDMB Act and drastically reducing the contract cycle.
- 7. External Audit for Suppliers commenced in the 2<sup>nd</sup> quarter of 2016.
- 8. NipeX has initiated the gradual deployment of its Spain Data center to its new 1. London Data center.

# **Policy of Excluding Errant Suppliers**

"Pursuant to Sections 16 and other relevant sections of the Public Procurement Act, 2007, of the Federal Republic of Nigeria (PPA) thereof, we at NipeX wish to state that any Supplier, Contractor or Service Provider who violates the provisions of the relevant sections of the PPA shall be excluded from participating in any tender opportunity and shall be blacklisted from the NipeX portal for a period of no less than One (1) year but no more than Three (3) years from the date of violation of the provisions of the PPA, to wit, any Supplier, Contractor or Service Provider who presents false documents, and misrepresents itself or its capacity, failed to perform or to provide due care in the performance of any public procurement amongst other violations as set out in PPA, or by NAPIMS Management, shall be banned from the NipeX portal."

## How to access bids on New SAP SRM NipeX 7.0 system


- Open an internet explorer page and type in www.nipex-ng.com into the address bar and click on the Go button. The public page of the portal is displayed.
- . Click on login and select emarket 7.0.
- 3. Enter your username and password in the fields provided and click on Logon. The secured area is displayed.
- 4. To access bid invitation (RFP, RFQ or DET), use the steps on the next page:

- A. Click on "NipeX RFX and Auction" tab.
- B. Click on "Work Center" tab and then click on "refresh" button.
- C. Click on the event number.



- Click on "participate" tab if you are interested in the bid. Click on do not participate in you are not interested in the bid and tentative if you have not made up your mind.
- Click on Technical Rfx to access the c-folder
- 5. For mass download of bid documents, use the steps in the snapshot below:



- ① On the vertical menu, Click on the external folder link to download documents.
- Click on mass download.
- Select the target directory and click on continue to download the bid documents.
