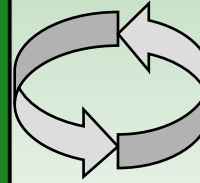

NipeX OPERATIONS: JQS & eMARKETPLACE

The Joint Qualification System (JQS) is designed to pre-qualify Suppliers registered in Nigeria. It increases efficiency and instills integrity in the pre-qualification process of the Nigerian oil and gas industry.



The eMarketplace is a collaborative environment that delivers significant value to all Stakeholders in the contracting process through a comprehensive suite of capabilities.

THE CHALLENGE OF PRODUCT CODES AND DPR PERMITS SELECTION

The following basic steps on product codes selection on DPR Permits prioritisation may be useful.

Basic steps on Product codes and DPR Permits prioritisation. Supplier should:

1. select desired product codes of services he/she is willing to provide noting that the supplier can register a maximum of twenty product codes as a new entrant.
 2. consider the itemised DPR Permit applicable to each of the product code selected.
 3. Conduct ranking of services and DPR Permits by considering some factors such as cost of procurement of the DPR permits, number of product codes covered, the available resource for the provision of the services, legal requirement and objective desire to venture into the service with strategic business continuity plan.
 4. Get the final list of the selected services, the applicable DPR Permits and other regulatory licences that may be required.
 5. Evaluate the required resources and decide on next line of action.
 6. Obtain all necessary permits in readiness for NJQS Registration
 7. Revisit NipeX Portal to commence registration.
- The NJQS Team hereby suggests that suppliers should utilise the **New NipeX Product Code Booklet Vs DPR Permit** before procuring DPR Permits if willing to achieve optimum result with minimum and reasonable resource. It should be noted that adoption of wrong approach may result in increase in resource that may be spent in procuring applicable permits.

Common errors by majority of new entrants into the NJQS.

1. Procurement of DPR Permits before considering NipeX Registration.
 2. Procurement of DPR before utilising NipeX Product Code Booklet
 3. Procurement of DPR Permits without linking it up with the company's Memorandum and Articles of Association.
 4. Selection of product codes without adequate knowledge on appropriate DPR Permits
 5. Selection of product codes without appropriate regulatory permits covering such services
 6. Wrong product codes selection
 7. Procurement of DPR Permit that may not be relevant to the scope of work the supplier intends to provide
- Procurement of DPR Permits without considering the long range sustenance of the requirement.

Consequence of inadequate management of entry process

- 1.0 Loss of man-hours in completing the NJQS registration process
- 2.0 Loss of financial resources on procurement of permits and licences
- 3.0 Loss of business opportunities that may come up before the completion of the process

THE CHALLENGE OF PRODUCT CODES AND DPR PERMITS SELECTION (Continue)

4.0 Possible loss of resources when supplier requests for product code addition due to improperly managed initial registration.

5.0 Unsatisfactory registration outcome propel by mismanagement of the entry process.

Question: I am a supplier who started NipeX registration in 2017 but abandoned the process. I later resumed the registration process in 2019 and received the NipeX Audit team for the Onsite audit. In 2019 My four DPR certificates did not match any of my registered product codes.

Kindly advise.

Answer: Please do the matching of product codes with DPR permit. This will enable you select the appropriate DPR permit with your registered product codes. Thereafter apply to DPR for the relevant DPR certificate.
