### ANATOMY OF A TENDER ADVERT... continue

- Mandatory Requirements: This states the eligibility criteria to participate in the tender including product code categories and how to register for the product code category or categories if the vendor is not eligible as per the criteria. It equally contains the physical office address of NipeX for ease of contacting NipeX and also the web address. Other eligibility criteria are equally stated clearly.
- Closing Date: This states the advert close date and time with a caveat stating that only vendors registered in the appropriate product category/ categories would be invited to bid.
- Additional Information: This contains other information not captured in the preceding parts such as other caveats. It equally contains the NipeX Vendor URL to help vendors ascertain the product codes
