Most pre-qualified suppliers miss out on published ITT/Bids for the simple reason that their company annual subscription has expired and the company status is now in the "EXPIRED" mode.

All companies in the NipeX data base are mandatorily required to renew subscription yearly and failure to do this makes the company to automatically lose its "LIVE" status and goes into the expired mode.

Most supplier complained of not being aware when/how to renew. The renewal date is the company anniversary date; that is the date the company is uploaded into the NipeX data base. This is communicated to a supplier on request via e-mail to [customersupport@nipex.com.ng](mailto:customersupport@nipex.com.ng). Alternatively, the supplier can obtain same information via a link sent by customer support.

To renew subscription, there are two basic steps involved namely:

- 1.0 Payment through remita
- 2.0 Documentation for NipeX renewal.

#### PAYMENT THROUGH REMITA

Log on to [www.remita.net](http://www.remita.net)

Click on pay a federal government agency

On the name of MDA, type National Petroleum Corporation  
Click on National Petroleum and Investment Management Services

Click on the box and then on National Petroleum and Investment Management fees

On Description, type the appropriate fees (₦20,000 for NJQS Renewal fees)

Fill in your company's name, E-mail and telephone number.

Key in the characters (usually four) into the box.

Click proceed to payment

Print out the page with the RRR code

Kindly make your payment either in a bank or

online.

#### DOCUMENTATIONS FOR NipeX RENEWAL

The required documents for NipeX renewal of subscription are:

1. The renewal form duly filled and completed
2. NipeX renewal receipt (₦20,000.00)
3. CAC – Certificate of Incorporation
4. CAC – Form CO2 – Allotment of shares
5. CAC – Form CO7 List of Directors
6. ITF – Industrial Training Fund: certificate of receipt of compliance or Application for waiver addressed to GM, NipeX (if staff are fewer than five and annual turnover is below fifty million naira)
7. Department of Petroleum Resources (DPR) valid certificate (not less than ₦25,000.00).
8. 3 years current company tax clearance certificate
9. VAT Certificate of TIN letter from FIRS
10. PENCOM Certificate or waiver application addressed to GM, NipeX (if staff strength is less than five and annual turnover is below fifty million naira).

Frequently Asked Questions

11. Bank reference letter—addressed to GM, NipeX at least six months current from your bank.

Question 1: How can I download or secure java?

Answer: Download java from internet explorer and install it.

To configure java, click on Security, Edit Site List, Add.

Type in <http://secure-nipex.com>

Click on OK, Continue

The java will be successfully secured.

Question 2. I am not seeing the Collaboration Room to upload.

Answer: Click on your response number. Click on Edit, Delete, OK, to confirm your command. Close the current page and go back to your Work Center.

Click on Refresh.

The response number won't be there again.

Click on the Event Number, Create Response and Save.

Click on Notes and Attachment.

By now you should be seeing the collaboration room.
