#### 1. INTRODUCTION

Chevron Nigeria Limited, Operator of NNPC/CNL Joint Venture, invites interested and prequalified indigenous companies for this tender opportunity for the Provision of Caterpillar Equipment and Engine maintenance Services which shall be in all Company's locations. This includes Chevron Nigeria Limited (CNL) Operational bases or at other locations as required to support CNL's oil and gas production activities including Projects, Shutdowns and Turnarounds.

The contract is proposed to span a period of two (2) years with a possible optional term of one (1) year duration.

#### 2. SCOPE OF WORK

The scope of work for the services includes the provision of a high standard of Caterpillar Equipment and Engine Overhaul Testing and Maintenance services. These services include but are not limited to the following:

- Engine overhaul and exchange of Caterpillar full oil and gas product line
- Testing / Overhaul Facility
- Equipment upgrading, servicing and repairs
- Small component overhaul
- Scheduled and unscheduled maintenance
- Periodic routine inspection and performance testing
- Diagnostics, troubleshooting and / or emergency inspection
- Corrective maintenance
- Engineering Assistance on Gas and Diesel Caterpillar Packages
- Field Service Support
- OEM Certified Training to Company personnel

Contractor's activity shall enormously contribute to Oil and Gas Production in the form of reliability and availability of the equipment within scope of services. To ensure that Contractor fulfils COMPANY requirement under the contract, Contractor may be required at short notice any time to make provision for an overhauled engine and execute unscheduled maintenance in order to restore the equipment to running condition. This may involve Emergency Response Telephone Assistance from the OEM's central engineering support staff.

The Contractor will be required to establish and develop for approval by COMPANY a "Three (3) Years Maintenance and Caterpillar Engine Exchange Program" including a work Schedule for the routine inspection and maintenance of the Gas and Diesel Caterpillar Packages and their ancillaries. The Plan will take account of the need for Contractor to review and improve equipment performance and produce monthly reports as well as advise on changes to procedures/ OEM service bulletins that may be recommended for the optimization of equipment performance.

Proposed services will be for maintenance and engine exchanges for Gas and Diesel Caterpillar packages supporting Chevron Nigeria Limited (CNL) oil and gas production facilities in offshore, land and swamp locations including operational and logistics base e.g. Lagos, Port Harcourt, Warri and other locations.

#### 4. NIGERIAN CONTENT REQUIREMENTS

Chevron Nigeria Limited is committed to the development of the Nigerian Oil and Gas business in observance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

Pursuant to enactment of the NOGICD Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the schedule of the Act and any other target as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

Contractors shall comply with the provisions of the NOGICD Act and all applicable regulations. Bidders that do not meet the Nigerian Content criterion will not be allowed to participate in next Tender Stage

The following are the Nigerian Content requirements bidders are expected to comply within their technical bid submission.

- Provide evidence of company Ownership Structure form CO2 and CO7, registration on NOGIC JQS and NUPRC certificate.
- Detailed description of the location of in-country committed facilities & infrastructure (technical office/administrative office, repair & maintenance) in Nigeria to support this contract.
- Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- Provide evidence Category C NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) and or Category 1-5 Procurement and Supplies (PS) NCEC. Demonstrating at least 50% Nigerian ownership of maintenance tools and equipment.
- Provide evidence of MOA with the OEM as the local OEM representatives.
- Provide evidence of what percentage of Management Positions are Nigerian personnel and what percentage of Nigerian personnel that shall execute the work scope
