• **SCOPE OF WORK**

The WORK to be covered under this CONTRACT generally consists of all works incidental and necessary to the successful completion of Construction, Replacement & Repairs of Flowlines in SPDC Producing Assets - Swamp services involving:

- Oil & Gas Flowlines construction
- Oil & Gas Flowlines replacement
- Oil & Gas Flowline repairs
- Well Head Platform Fabrication and Installation
- Flow station emergency (piping & structural) repairs

**3.0 MANDATORY REQUIREMENTS**

To be eligible for this tender exercise, interested contractors are required to be pre-qualified in the Product Group: 4.03.04, 4.04.04 and 4.05.04 in NipeX Joint Qualification System (NJQS) data base. Only successfully pre-qualified suppliers in all three of these categories will receive Invitation to Technical Tender (ITT).
2. To determine if you are prequalified and view the product/service you are listed for: open [www.nipex-ng.com](http://www.nipex-ng.com) and access NJQS with your log in details, click on "Continue Joint Qualification Scheme Tool" button, click "check my supplier status" and then click 'Supplier Product Group'.
3. If you are not listed in a product/service category you are registered with NUPRC to do business, contact NipeX office at 27b Oyinkan Abayomi Drive, Ikoyi, Lagos with your NUPRC certificate as evidence for necessary update.
4. To initiate the JQS prequalification process, access [www.vendors.nipex-ng.com](http://www.vendors.nipex-ng.com) to download the application form, make necessary payments and contact NipeX office for further action.
5. To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

**4.0 NIGERIAN CONTENT REQUIREMENTS**

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and also provide the following requirements:

- Demonstrate that entity is a Nigerian registered company with greater than 51% Nigerian shareholding. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc.) including company memorandum & article of association and/or evidence of entity's incorporation, shareholding & ownership structure in Nigeria. Tenderer shall provide evidence of NCDMB NOGIC JQS registration.
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- Tenderer shall provide Location of in-country facilities (not limited to administrative office, maintenance workshop, fabrication workshop) to execute the work scope.
- Bidder shall provide valid Category 1,2,3, 4 or 5 of the following NCEC to execute the work scope.
  1. Construction and Movable equipment (EC) group demonstrating ownership of construction and maintenance equipment for repair of flowlines
  2. Fabrication and Construction (FC) group demonstrating ownership of fabrication equipment for Construction, Replacement, and Repair of Flowlines
