1. INTRODUCTION

Esso Exploration and Production Nigeria Limited (EEPNL/EEPN(OE)L), contractor of NNPC/EEPNL Production Sharing Contract plans to engage services of competent Contractors for the Provision of Deepwater Oil Field Production Chemicals to its Deepwater Facilities - Erha / Usan FPSOs for an anticipated contract term of five (5) years with two (2) years optional renewal period.

2. SCOPE OF WORK

Chemical Management Services

This shall include provision of services in relation to day-to-day management of the chemical treatment program and the asset production laboratory activities to ensure the following objectives:

- Oil and gas production is not constrained by any chemical-related issue
- · Esso and government produced water quality targets are met
- Internal corrosion rates are contained within defined limits, and the integrity of Esso equipment is appropriately maintained
- Individual system dosage rate is maintained at the optimum level on an appropriate basis
- An industry-standard laboratory quality system is provided and production laboratory operations are managed in accordance with this system
- Education and training of Esso personnel in the correct handling and application of supplied products such that no safety, health, or environmental incidents occur
- · Continual improvement of the performance of oil field chemicals through a structured program
- To provide recommendations for other chemical applications, such as equipment preservation
- Environmental impact is minimized

Supply of Chemical

It is anticipated that the chemicals and materials to be supplied may include, but are not necessarily limited to the following:

- 1. Flow Assurance Specialty Chemicals: scale inhibitors (calcium carbonate, barium sulfate), demulsifiers, water clarifiers, low dosage hydrate inhibitors, preservation formulations, scale dissolvers, wax dissolvers, pour point depressants, anti-foams.
- 2. Asset Integrity Specialty Chemicals: corrosion inhibitors (multiphase, aqueous, closed system, glycol, gas), biocide, oxygen scavenger
- 3. Third Party Specialty Chemicals: chemicals that offer superior performance to Supplier's normal supply
- 4. Commodity Chemicals: ethylene glycol, triethylene glycol (TEG), oxygen scavenger, methanol
- 5. Third Party Utility Chemicals: Detergents, fire fighting chemicals, hydraulic fluids
- 6. Laboratory Chemicals and Equipment: reagents, solvents, consumables, and test equipment to maintain offshore and onshore analytical laboratories

3. MANDATORY REQUIREMENTS

4. NIGERIAN CONTENT

Company is committed to the development of the Nigerian Oil and Gas business in compliance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

"Nigerian company" is a company formed and registered in Nigeria in accordance with the provisions of Companies and Allied Matters Act with not less than 51% equity shares by Nigerians.

Tenderers shall consider Nigerian content as an important element of their overall project development and management philosophy for project execution.

As part of their submissions, Tenderers shall:

- Demonstrate that entity is a Nigerian registered company. Tenderer shall provide evidence of company Ownership Structure form CO2 and CO7, registration on NOGIC JQS and NUPRC certificate.
- Provide detailed description of the location of in-country committed facilities & infrastructure (Administrative/Technical offices, workshops, and blending facility) in Nigeria to support this contract.

- Provide evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerian Nationals and the percentage of the total workforce that are Nigerians.
- Tenderers shall provide evidence of cat. A NCEC for in-country blending plant and or provide evidence of Category 1,2, or 3, NCEC for Services and Support Group (SS) group demonstrating ownership of in-country blending plant for execution of the work scope.
- Tenderer shall comply with the latest approved version of NCDMB HCD GUIDELINE by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

Tenderer's failure to comply with the NOGICD Act or demonstrate commitment to Nigerian Content Development will result in Tenderer's disqualification.
