1.0 Introduction:

Contract shall be on a call-out basis with a primary term of two (2) years with an option to extend for an additional one (1) year under same terms and conditions.

- A. To be eligible for this tender exercise, interested bidders are required to be pre qualified in category 3.18.18, 3.18.19 & 3.02.01 in NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified suppliers in this category by the bid close date will receive Invitation to Technical Tender (ITT).
- B. Please note that interested bidders including their sub-contractor(s) shall be required to:

- Meet all NJQS mandatory requirements to be listed as "PREQUALIFIED" for a category in the JQS database.
- 2. Meet all Nigerian Content requirements stated in this advert in their responses to the Invitation to Technical Tender.
- C. To determine if you are pre-qualified and view the product/service category you are listed for: Open www.nipexng.com and access NJQS with your log in details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click supplier product group.

4.0 Nigerian Content

- A. Demonstrate that entity is a Nigerian indigenous service company with having 51% and above Nigerian equity shareholding in the ownership structure of the legal registered entity of tenderer in Nigeria and duly registered on the NCDMB NOGIC JQS as service providers under the applicable and relevant product category. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc.) and other evidence of entity's incorporation, shareholding & ownership structure in Nigeria. Maximizing Nigerian Content is a key contract priority, therefore Nigerian Indigenous Company in alliance with foreign and multinationals companies must provide evidence that the Nigerian indigenous company will be the lead and submit the binding memorandum of Agreement (MOA) of the alliance. This MOA will:
- I. Be governed by the laws of the Federal Government of Nigeria.
- II. Show scope of work each party will perform in executing the work scope.
- III. Signed and dated by the Managing Director of both parties.
- IV. Show a schedule of the list of equipment and personnel that will be supplied to execute work scope.
 - B. Tenderer shall demonstrate evidence of valid DPR certificate for Manpower supply.
 - C. Tenderer shall provide a letter of undertaking that only Nigerian personnel shall be deployed for the contract execution and no Expat Personnel shall be deployed during the contract execution without obtaining expatriate quota from NCDMB consistent with the NOGICD Act 2010 and the latest NCDMB approved guideline on Expatriate Quota.
 - D. Tenderer to provide verifiable evidence of detailed location of in-country facility of warehouse, office, yard workshop, laboratory and camp (certificate of ownership, lease agreement, layout drawings and photographs) or a Binding Memorandum of Agreement, duly signed by the chief executive of both parties, supporting an alliance with any existing in-country facilities' owner(s)
 - E. Provide details of project-specific training, man-hour budget, skill development and technology transfer plan for Nigerian personnel according to work scope. Include evidence of past performance on training and development for Nigerians nationals. Plan for sponsorship of Nigerians to acquire competence and/or certification.
 - F. Provide evidence of approved Nigerian Content Equipment Certificate Category "CS" (or valid Category "C" under previous NCEC guidelines of period status of the application submitted to NCDMB for the certificate.
 - G. Produce a List of materials that will be procured from Nigerian Manufacturers. Applicants shall submit the list of products, materials and consumables for performing the service and the source of supply for each item
 - H. Produce a plan of how it intends to measure Nigerian Content Performance against set targets.

5.0 Closing Date:

Only bidders who are registered with NJQS Product/Category 3.18.18, 3.18.19 & 3.02.01 by 16:00 Hours, 8th of September 2022 being the advert close date shall be invited to submit technical bid.

Please note the following:

- Suppliers eligible for this tender opportunity are expected to be prequalified in NJQS under this
 product/service category.
- 2. The Invitation to Tender (ITT) and any further progression of this tender shall be via NipeX.
- All costs incurred in preparing and processing NJQS prequalification shall be to the contractor's accounts.
- 4. Meet the requirement of Surveyors Registration Council of Nigeria (SURCON) for survey activities in Nigeria.
- 5. This advertisement shall neither be construed as any form of commitment on the part of Enageed Resource

Limited to award any contract to any company and or associated companies, sub-contractors or agents, nor shall it entitle prequalified companies to make any claims whatsoever, and/or seek any indemnity from Enageed Resource Limited and or any of its partners by virtue of such companies having been prequalified in NJQS.

- 6. The tendering process shall be the NNPC contracting process requiring pre-qualified companies to submit technical tenders first. Following a technical review, only technically and financially qualified contractors will be requested to submit commercial tenders.
- 7. Enageed Resource Limited will communicate only with authorized officers of the pre-qualifying companies and NOT through individuals or Agents.
- 8. Contract shall be awarded equally to five (5) technically qualified bidders at the lowest bidder's price. Three (3) of these bidders shall provide skilled personnel while the other two (2) bidders shall provide semi-skilled and unskilled personnel. All bids must satisfy minimum NCDMB target to be considered for award.
- 9. Contract expected Primary Term is two (2) Years with one (1) Year Option.
- 10. Currency Split to be 100% Naira.
