1. INTRODUCTION:

HEIRSHOLDINGS OIL & GAS LIMITED (hereinafter referred to as "HHOG") seeks interested and pre-qualified Contractors for Provision of Electric Wireline Services in OML 17 on a call-off basis as detailed in item 2 below. The contract is proposed to commence in Q1 2023 and continue for a duration of Three (3) years with an option to extend for additional period of two (2) years.

2. SCOPE OF SERVICES:

Provide equipment, consumables, personnel, and back-up which shall include but not limited to:

- i. Provide Wireline logging and formation evaluation including open hole and cased hole services.
- ii. Provide through tubing or casing gun perforating and subsequent production logging services.
- iii. Provide pipe recovery services including drill string & production string tail and perform subsequent back-off or string severing with explosive, mechanical, chemical and/or water jet cutters as and when required.
- iv. Provide fishing services for all tools capable of being fished using wireline.
- v. Perform drill pipe or tubing punching to re-establish circulation in the drill string when required whilst maintaining the safety standards for execution of such services.
- vi. Run and set packers, cement retainers and/or bridge plugs and other third-party equipment as required.
- vii. nipples plug installation and retrieval
- viii. Acquire, record, store all well evaluation data; process, interpret and/or transmit in the required format specified.
- ix. Perform data processing and analysis on evaluation results.
- Provision of appropriate conveyance systems as required (Tractor Services, Pipe conveyed logging services, Through tubing conveyance services).

3. MANDATORY REQUIREMENTS:

- 3.1. To be eligible for this tender exercise, interested Tenderers are required to be pre-qualified in the 3.04.11 Fishing/Wireline Fishing Services and 1.01.10 Wireline Equipment and Accessories (Product/Service) category in NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified Contractors in this category will receive invitations to Tender.
- 3.2 To determine if you are prequalified and view the product/service category you are listed for: Open http://vendors.nipex-ng.com and access NJQS with your log in details, click on continue Joint Qualification scheme tool, click check "my supplier status" and then click supplier product group.
- 3.3 If you are not listed in this product/service category and you are registered with NUPRC, please contact NipeX office at No.8 Bayo Kuku Street, Ikoyi Lagos with your NUPRC certificate as evidence for verification and necessary update.
- 3.4 To initiate the JQS pre-qualification process, access <u>www.nipexng.com</u> to download an application form, make necessary payments and contact NipeX office for further action.
- 3.5. In addition, Tenderers shall also be required to comply with the Nigerian Content requirements in the Nigerian Oil & Gas Industry Content Development Act 2010.

4. NIGERIAN CONTENT REQUIREMENTS:

Tenderers are to note that they will be requested during the technical tender to provide details of their relevant strategy to ensure that they fully comply with the Nigerian Oil & Gas Industry Content Act, 2010 as provided at www.nnpcgroup.com and <a href="https://www.

The Nigerian Content Development Monitoring Board (NCDMB) will require each Tenderer to:

- Demonstrate that the entity proposed for execution of the service, is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work. Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies including evidence or plans of physical operational presence and set-up in Nigeria
- Furnish details of company ownership and shareholding structure. With photocopies of its CAC Forms CO2 and CO7
- Provide evidence of what percentage of its key management positions are held by Nigerians and what percentage of the total work force are Nigerians. And show overall percentage of work to be performed by Nigerian resources relative to total work volume.
- Provide a Nigerian Content Plan with detailed description of the role, work scope, man-hours and responsibilities of all the Nigerian companies and personnel that will be involved in executing the work.
- State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidence of well-equipped offices and workshop.
- 6. In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution (s).
- 7. Provide evidence of domiciliation of project management and procurement centers in Nigeria with physical addresses (not P.O. Box).
- Provide detailed description of the location of in-country facilities (Equipment, storage, workshops, repair, maintenance and testing facilities
- Provide detailed statement with evidence of how it intends to maximize the use of Nigerian made goods and services.
- 10. Provide evidence of registration with NCDMB NJQS.
- 11. Bidders to provide valid NCEC Category "SS" for Service & Support Group.
- 12. Provide details on any other Nigerian Content initiative the company is involved in.

5. CLOSING DATE
