1. INTRODUCTION

Mobil Producing Nigeria Unlimited (MPN) operator of the NNPC/MPN Joint Venture (JV) plans to engage competent and qualified Companies to provide **Permanent Down hole Gauges Data Retrieval And Maintenance Services** for its development Drilling &Well work Program operations on its offshore location(s) in NNPC/MPN JV acreages.

Anticipated contract term is two (2) years with an additional one (1) year optional period.

2. SCOPE OF WORK

The scope of work shall involve the provision of specifications for the data retrieval from existing permanent down hole gauges, the equipment and services to repair or replace the surface power supply, the equipment and services to repair or replace the surface acquisition equipment, the equipment and service to maintain existing surface Permanent Down hole Gauges (PDHG) equipment, and other related consumable Goods and Services for Permanent Down hole Gauges Data Retrieval and Maintenance Service .

Equipment will include; Down hole Pressure and Temperature Gauges System, the equipment to power the gauges, the equipment to acquire/record the gauge data, electrical conductor, cable clamps, solar panels/ battery packs and Portable Acquisition Units (PAU). Suppliers must own equipment or have MOU with OEM

Company's completions will utilize DHPT gauges to determine the down hole pressure and temperature conditions of the wellbore. The DHPT gauge will be placed approximately 30ft above the production packer in the completion string. The permanent gauge will be housed inside an offset pocket of the DHPT gauge mandrel. An electrical conductor, housed in a 1/4" conduit encapsulated in a crush resistant polymer sheath will transmit telemetry from the gauge. Cable clamps will support the cable and enhance crush resistance.

3. MANDATORY REQUIREMENTS

- (a) To be eligible for this tender exercise, interested Tenderers are required to be prequalified and have LIVE status in the 3.15.04 (Well Services) category in NipeX Joint Qualification Scheme (NJQS) database. All successfully pre-qualified suppliers in this category will receive Invitation to Tender (ITT).

- (e) To be eligible, all tenders must comply with the Nigeria Content requirements in the NipeX system.

4. NIGERIAN CONTENT

Company is committed to the development of the Nigerian Oil and Gas business in compliance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the Schedule to the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

NNPC/MPN JV requires their Contractors to comply with the Act, its attached Schedule and any applicable regulation developed by the NCDMB.

Nigerian Content (NC) in the Nigerian oil and gas industry is defined as:

"The quantum of composite value added to or created in the Nigerian economy by a systematic development of capacity and capabilities through

the deliberate utilization of Nigerian human, material resources and services in the Nigerian oil and gas industry."

"Nigerian company" is a company formed and registered in Nigeria in accordance with the provisions of Companies and Allied Matters Act with not less than 51% equity shares by Nigerians.

Tenderers shall consider Nigerian content as an important element of their overall project development and management philosophy for project execution.

As part of their technical tender submissions, prequalified Tenderers shall:

- (a) Demonstrate that entity is a Nigerian registered company. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc.) including company memorandum & article of association and/or evidence of entity's incorporation, shareholding & ownership structure in Nigeria
- (b) Tenderer shall provide evidence of NCEC Category 1,2,3,4 or 5 under the Services and Support group (SS), to demonstrate capacity and capability in executing the work scope.
- (c) Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- (d) Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- (e) Tenderer shall provide Location of in-country facilities (not limited to administrative office) to execute the work scope

Tenderer's failure to comply with the NOGICD Act or demonstrate commitment to Nigerian Content development will result in Tenderer's disqualification.

5. CLOSING DATE

Only Tenderers who are registered and have **LIVE** status in the **3.15.04 (Well Services)** category in NipeX Joint Qualification Scheme (NJQS) database as at**1600 hours** on**23 Dec 2022** being the advert closing date shall be invited to submit Technical Bids.
