#### 1. INTRODUCTION

Nigerian Agip Oil Company Limited (NAOC) intends to award one (1) Contract for Brass Produced Water Management Project.

The work estimated to be completed within 24 Months from the commencement date of contract.

NAOC therefore invites submissions for the purpose of technical evaluation from suitable and reputable companies having the capability and experience to undertake the under defined scope of work:

#### 2. SCOPE OF WORK

The scope of work for this process covers but is not limited to the following activities:

- 1. The Project Management, Detailed Engineering, Procurement, Construction/Installation and Testing/Pre-Commissioning/Commissioning of a New Integrated Produced Water and Storm water Treatment System comprising Dissolved Nitrogen Floatation Package, Polishing (Walnut Shell Filtration, GAC Filtration, Filters Backwash Facilities) Package, Water Disposal Pumps, Retention/Holding Basins, Chemical Injection Package, Nitrogen Generation Package, Satellite Electrical Substation and other treatment equipment to enhance the treatment of the produced formation water and contaminated storm water including all related in-plant piping and piping appurtenances, Electrical Works, Civil Works, Instrument Works & Control, tie-ins to existing facilities, etc.
- 2. The Project Management, Detailed Engineering, Procurement, Construction/Installation and Testing/Pre-Commissioning/Commissioning of the Pipeline System 9km X 24" or 23km X 24" offshore Pipeline and 2km x 24" onshore Pipeline and all the required subsea equipment and cathodic protection system, including all crossings and all related civil works, such as site clearing, grading, trenching & backfilling, interconnection spool and subsea structures etc.
- 3. Carry out Mobilization/Demobilization activities including the provision of all facilities and resources associated with construction, including construction camp, living camp, site offices, construction tools, transport and labour, lifting equipment, materials, supervision etc.

In other for Vendor to be technically eligible to perform the activity, tenderer must be able to meet the following minimum requirements amongst others:

- Tenderer shall provide evidence of having completed both onshore EPCI and Offshore Pipeline Installation projects not less than Fifty Million US Dollars (USD50M) for each project as either main works contractor or lead contractor in a consortium
- Demonstrating that not more than 40% of the entire Scope of Work (EPC Offshore pipeline Installation and EPC Onshore) foreseen for the Brass Produced Water Management Project shall be subcontracted. (This is exclusive of the S-Lay installation vessel)
- c) Tenderer shall provide evidence of ownership of an S-Lay Installation Vessel suitable for a maximum water depth of 65m, Verifiable evidence shall include proof of ownership of the installation vessel or properly executed MOA (MEMORANDUM OF AGREEMENT) with the owner of the proposed vessel with names of operator representatives that can be contacted for verification, vessel characteristics and location.
- d) Tenderer shall Provide evidence (i.e. audited annual financial report) to demonstrate having an average turnover/revenue higher than 100 MUSD in the last 3 years

  e) BIDDER shall provide DPR Certificate relevant for Onshore EPCI Facilities project,

Onshore and Offshore Pipeline installation project as a minimum

- 2. Detailed description of the location of in-country committed facilities & infrastructure (Administrative/Technical offices, workshop, assembly area, etc) in Nigeria to support this contract.
- 3. In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- 4. Submit Tenderer's corporate organizational and project/contract specific organogram. CV's of all personnel (as required by the Client and the service) listed in the project organogram should be submitted. For any position to be occupied by expatriate, tenderer shall provide evidence to obtain expatriate quota approval granted by NCDMB before any expatriate is deployed to execute this work scope\*.
- 5. Provide evidence of at least 50% Nigerian ownership of Equipment as stated in the scope of work.
- 6. Provide Category C NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) issued by Nigerian Content Development and Monitoring Board in respect of the mentioned equipment.
- Details of in-country procurement plan and Binding MOA to source goods and materials
