INTRODUCTION

The Nigerian Agip Oil Company limited (NAOC) has a requirement to issue SOLID CONTROL EQUIPMENT AND SERVICES contract for the Scope of Work identified below on NAOC land and swamp area wells for three (3) years firm period and two (2) one (1) year optional

NAOC therefore invites submissions for the purpose of technical evaluation from suitable and reputable companies having the capability and experience to undertake the under defined scope of work:

SCOPE OF WORK

Contractor shall supply and change-out / install, operation, servicing and maintenance Solids Control Equipment and ancillary equipment, tools and hoses (Shale Shakers, HI-G Dryers, Screens, Single or Dual centrifuges on-line system) on board of the rig for Company drilling operations in Nigeria.

This Work shall be performed in accordance with the specifications contained here-in and the Contract in general.

It is of utmost importance to carry out all activities with minimum impact on the environment and maximum care of health and safety of all concerned, directly or indirectly, with the activities.

The Contractor shall perform the work in accordance with Company operating instructions or Contractor's written operating instructions approved by Company, utilizing its own know-how and operating experience.

Contractor shall plan, direct, supervise and control operations of Solids Control Equipment. Consequently Contractor shall:

- Perform Solids Control operations and associated services including but not limited to operating, servicing, maintenance and testing of all items of equipment and ancillary and optional equipment in accordance with the well specifications on a day-rate basis or on an Incentive basis as described herein:
- Provision of high volume, variable speed centrifuges with associated feed pumps, high speed cuttings dryers, feed pumps, effluent tanks, screw augers and other equipment necessary for reducing oil on cuttings emissions and potential zero fluid discharge operation.
- Furnish all equipment, labor, materials for installation of solids control equipment and associated piping onto the selected drilling rig.
- Provision of experienced onshore/swamp solids control technicians for solids d) control system monitoring, maintenance and repair of equipment provided and integrated drilling fluid system planning.
- e) Furnish all equipment, materials and services specified
- Provision of shaker screen inventory for rig based shakers. f)
- Carry out and co-ordinate all onshore storage and transport of Contractor Items g) and Personnel, to and from the Company Supply Base and to and from Rig Site;
- Execute all work in connection with this Scope of Work. h)

CLOSING DATE

Failure to meet any of these requirements shall lead to outright disqualification.

CONTRACTOR shall conform to ISO 9000 series International Standard. All the activities shall be carried out with minimum impact on the environment and maximum care of health and safety of all concerned, directly or indirectly, with the activities.

NIGERIAN CONTENT REQUIREMENT

- 1. Tenderer shall demonstrate evidence of being a Nigerian indigenous company having greater than 51% Nigerian shareholding. Provide evidence of company Ownership Structure forms CO2 and CO7, registration on NOGIC JQS and NUPRC certificate.
- 2. Detailed description of the location of in-country committed facilities & infrastructure (Administrative/Technical offices, workshop, etc.) in Nigeria to support this contract.
- 3.Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- 4. Tenderers shall provide evidence of valid NCEC Category 1,2,3,4 or 5 for Services and Support (SS) group to demonstrating ownership of equipment not limited to Solid Controls equipment to execute work scope
- 5. Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.

NOTE: Non-compliance with Nigerian content requirements is a FATAL FLAW.
