1. INTRODUCTION

Nigerian Agip Oil Company limited (NAOC) intends to issue Contract FOR FLUIDS FILTRATION EQUIPMENT AND SERVICES SUPPLY on NAOC Land and Swamp Area wells, for two (2) years firm period plus one (1) year optional extension.

NAOC therefore uses this medium to inform suitable and reputable Companies having requisite experience, available equipment, consumables and resources for the execution of the project of this magnitude to register or update their registration with NipeX for consdieration in the subject opportunity.

2. SCOPE OF WORK/SERVICE REQUIREMENT

Contractor will supply on the rig site completion/work-over brine filtration services. Contractor shall provide qualified personnel and filtration units capable of processing brines at sustained rate of 12 bpm each (24 bpm total) through diatomaceous earth (DE) filter presses in series with 2 micron (beta = 2000) dual cartridge filter pods to < 20 NTU using turbidity meter

The DE units shall have the ability to regenerate while online. The dual cartridge units shall have a wash out drain and be capable of handling sustained flow rates greater than the DE units.

Contractor shall have adequate equipment and qualified personnel to provide engineering services, adequate equipment shall include back-up equipment for use during periods of scheduled and unscheduled maintenance.

Contractor shall supply all ancillary equipment required to filter dirty brine from the rig mud pit system and return clean brine to rig mud pit system

3. MANDATORY REQUIREMENTS

To be eligible for this tender exercise, interested contractors are required to be pre-qualified in the product code **3.04.31** – **Wellbore cleanout and filtration Service**

(Products/Services Category) in the NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified suppliers in these categories will receive Invitation to Technical Tender (ITT).

4. NIGERIAN CONTENT

- Tenderer shall demonstrate that entity is a Nigerian-registered company with greater than 51% Nigerian shareholding as described in the NOGICD Act. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc) and other evidence of entity's incorporation, shareholding & ownership structure. Tenderer shall provide evidence of registration on the NCDMB NOGICJQS.
- 2. Tenderer shall also provide evidence of committed in-country facility not limited to offices, administrative building, warehouse(for equipment storage, storage of spare parts), workshop for Maintenance of equipment.
- 3. Provide a project-specific organogram showing Names and Nationalities of all key personnel not limited to Base Manager, Filtration Unit Supervisor, Filtration Unit Operator etc. that will execute the work scope for this service. CV's of these personnel should also be submitted. For any position to be occupied by Expatriate personnel, tenderer shall commit to obtaining expatriate quota approval from NCDMB before project execution.
- 4. Tenderer shall provide evidence of a valid category C NCEC for the equipment that shall be utilized in the execution of the work scope.
- Tenderer shall provide evidence of at least 50% Nigerian ownership of Filtration equipment to be deployed for this service.
- In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

NOTE: Non-compliance with Nigerian content requirements is a FATAL FLAW
