### 1. INTRODUCTION

The Nigerian Agip Oil Company limited (NAOC) has a requirement to issue INTEGRATED PROJECT OF WELL INTEGRITY SERVICES contract for the Scope of Work identified below on NAOC land and swamp locations for two (2) years firm period plus one (1) year optional extension.

NAOC therefore invites submissions for the purpose of technical evaluation from suitable and reputable companies having the capability and experience to undertake the under defined scope of work:

#### 2. SCOPE OF WORK

The COMPANY requires the services of a specialised CONTRACTOR able to carry out the following services for the provision of Integrated Project of Well Integrity Services for **NAOCJV in land and swamp areas**.

The following activities are foreseen, but not limited, to be performed with the equipment:

- Inspection and maintenance (e.g. clean, greasing, etc.) WH & X-MAS elements
- Repair, Remanufacture or Replacement, when it is necessary
- Installations
- Testing (e.g. functionality test of xmas tree valves, Timing of closures of actuated valves, etc.)
- Test downhole safety valve
- Annulus pressure check and bleed off
- Working in confined space (well cellar)
- Provide equipment, consumables and services for the application of sealant injection for curing Wellhead packoff and hanger seals when required by the COMPANY
- Transportation of CONTRACTOR PERSONNEL, tools and equipment a s well as COMPANU's Wellhead and Christmas Tree assemblies and components between CONTRACTOR's local base and the OPERATING AREA.
- Suitable lifting equipment and lifting devices to enable COMPANU's Wellhead and Christmas Tree assemblies and components to be loaded to, and unloaded from, CONTRACTOR's transport.
- Provision of well integrity desk engineer
- Retrieve, redress and installations of ambient valves
- Retrieve, redress and installations of difference down hole plugs
- Retrieve, redress and installations of back pressure valves in the tubing hanger
- Well killing operations
- Nipple up and nipple down Christmas trees
- Commissioning

#### Failure to meet any of these requirements shall lead to outright disqualification.

CONTRACTOR shall conform to **ISO 9000** series International Standard. All the activities shall be carried out with minimum impact on the environment and maximum care of health and safety of all concerned, directly or indirectly, with the activities.

#### 4. NIGERIAN CONTENT REQUIREMENTS

Bidders are invited to express complete understanding, willingness and commitment to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act, 2010 and. Insurance ACT 2003 Consequently, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act.

The documentation for evaluation shall include but not be limited to the following:

- a) Demonstrate that entity is a Nigerian-registered company with greater than or equal to 51% Nigerian shareholding. Submit certified true copies of CAC forms 10,02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc) and other evidence of entity's incorporation, shareholding & own ership structure in Nigeria. Tenderer shall provide evidence of registration on the NCDMB NOGICJQS.
- b) Tenderer shall provide detailed description of the location of incountry committed facilities not limited to technical and administrative office.
- c) Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- d) Tenderers shall provide evidence category 1, 2, 3 and 4 NCEC for Services and Support Group NCEC demonstrating ownership of Slickline & Pumping equipment to be utilized in execution of the work scope.
- e) Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
