**1. INTRODUCTION**

The Nigerian Agip Oil Company Limited (NAOC) has a requirement to issue contracts for Supply & Monitoring of Production & Gas Treatment Chemicals for land and swamp area operations for three (3) years firm period plus one (1) year optional extension.

NAOC therefore invites submissions for the purpose of technical evaluation from suitable and reputable companies having the capability and experience to undertake the under defined scope of work:

**2. SCOPE OF WORK**

The task to be performed by Contractor shall include but not limited to the following:

- Supply of chemicals on time and according to Company's requirements
- Carry out all analysis as listed by the Company (de-emulsifier performance, SRB counts, corrosion rates, scaling rates, etc.) in order to ensure proper performance of chemicals
- Continuous optimization, improvement and implementation of the production chemicals application under the supervision of Company personnel.
- Contractor shall maintain a corrosion inhibitor program for LAR/SAR that ensures a corrosion rate below 3 mpy.
- Custody of chemical injection equipment, including the preventive and corrective maintenance of the parts and accessories installed and the supply of spare parts and components required, guaranteeing the storage, efficient and reliable injection of chemical products, as well as ensuring the appropriate functioning of all equipment in order to guarantee a successful chemical treatment program.
- The chemical storage tanks must be regularly checked to ensure timely refill. This is to avoid alteration of dose rates in order to conserve stocks.
- Provide trained personnel to assist the Company's Laboratory in the measurement and analysis of the most common parameters related to the chemical treatment
- Submit the daily and monthly chemical reports and handling a comprehensive database for easy follow-up of chemical treatment
- Tracking of system changes in order to adjust program accordingly
- Periodic data logs shall be prepared and presented to company.

1. Tenderer shall provide evidence of being a Nigerian registered company having greater than 51% Nigerian shareholding. Provide evidence of CO2 and CO7, registration on NOGIC JQS and DPR certificate.
2. Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total workforce are Nigerians.
3. Detailed description of the location of in-country committed facilities & infrastructure (Administrative/Technical offices, workshop and blending facility) in Nigeria to support this contract.
4. Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
5. Tenderer shall provide evidence of Category 1,2,3,4 or 5 Services and Support (SS) NCEC group and or category 1,2,3,4 or 5 Construction and Moveable equipment NCEC demonstrating ownership of Blending Plant to execute the work scope.
