#### 1. INTRODUCTION

Nigerian Agip Oil Company limited (NAOC) intends to issue contract for Water Base Waste Management Services for NAOC JV operations on NAOC land and swamp area wells, for three (3) years firm period plus two (2) year optional extension.

NAOC therefore uses this medium to inform suitable and reputable companies having requisite experience, available equipment, consumables and resources for the execution of the project of this magnitude to register or update their registration with NipeX for consideration in the subject opportunity.

#### 2. SCOPE OF WORK/SERVICE REQUIREMENT

##### Contractor Shall

- Contractor shall: CONTRACTOR shall supply all equipment, including consumables and spare parts, vehicles, qualified personnel, technical assistance and documentation necessary to carry out WBM waste management operations
- Provide personnel necessary to plan and co-ordinate, supervise and perform the services.
- Provide assistance and technical support to WELL SITE personnel.
- Provide technical interface to COMPANY.
- Perform water base mud drilling waste collection, transportation, treatment and reuse/disposal services including but not limited to collection of effluents/drilled cuttings and treating at contractor's site or rig-site reuse/dispose in accordance to the regulatory authorities (DPR and other relevant bodies).
- Provide the necessary equipment and goods, including consumable, spares and maintenance.
- Supply timely the requested quantity and quality of materials, equipment, tools and goods to perform the work.
- Provide all the quality control documents related with supplied tools, equipment and goods.
- Carry out, co-ordinate and move CONTRACTOR equipment and goods to and from the WELL SITE / EMBARKATION POINT.
- Implement a program for maintenance and calibration of the equipment. Such program shall be available for COMPANY's verification.
- Provide all the quality control and HSE documents related to personnel and to the supplied tools, equipment and materials.
- Prepare and submit the necessary detailed technical reports and other documentation as directed by COMPANY.

#### 3. MANDATORY REQUIREMENTS

To be eligible for this tender exercise, interested contractors are required to be pre-qualified in the product code **3.01.08\_Waste water Treatment Services and 3.15.07\_Waste Management Services** (Products/Services Category) in the NipeX Joint Qualification System (NJQS) database. **All successfully pre-qualified suppliers in these categories will receive an Invitation to the Technical Tender (ITT).**

#### 4. NIGERIAN CONTENT REQUIREMENTS

Bidders are invited to express complete understanding, willingness and commitment to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act, 2010 and Insurance ACT 2003. Consequently, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act.

In line with the relevant provisions of the NOGICD Act, 2010 and the NCDMB-approved Filtration Unit utilization strategy, First considerations shall be given to bidders that demonstrate evidence of utilization and Nigerian-ownership of Filtration Units or Nigerian-equity acquisition within the nominated Filtration services (land/swamp etc.) or the Bidding entity (supported by verifiable evidence) propose to deploy and utilize for the service a nominated Nigerian-owned Filtration Unit (Land/swamp, providing MOA for a Filtration Unit owned by a Nigerian 3rd party).

The documentation for evaluation shall include but not be limited to the following:

- i. Demonstrate that entity is a Nigerian registered company with 51% or shareholding capacity. Tenderer shall provide evidence of company Ownership Structure form CO2 and CO7, registration on NOGICJQS and DPR certificate.
- ii. Tenderer shall provide detailed description of the location of in-country committed facilities & infrastructure (Administrative/Technical offices) in Nigeria to support this contract.
- iii. Provide evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerian Nationals and the percentage of the total workforce that are Nigerians.
- iv. Tenderer shall provide evidence category C NCEC demonstrating ownership of waste management equipment and or evidence of category 1, 2, or 3 NCEC for Construction and moveable Equipment group (EC).
- v. Tenderer shall comply with the latest approved version of NCDMB HCD GUIDELINE by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

**NOTE: Non-compliance with Nigerian content requirements is a FATAL FLAW**
