1.0 Introduction

THE SHELL PETROLEUM DEVELOPMENT COMPANY OF NIGERIA LIMITED hereby invites reputable and competent Nigerian Companies with the requisite expertise, experience, skilled manpower and technology to apply to be considered for inclusion in the bid list for the above tender.

Scope of Work/ Service Requirements

CONTRACTOR shall provide as a minimum:

A: First line/Preventive Maintenance services as per industry best practice on flowing (oil/gas), shut-in or suspended wells covering land, swamp and offshore terrains and includes as a minimum:

- Visual Inspection of Wellhead and Accessories,
- Function test, inflow test (where there are wellhead pressures) and/or pressure test (where there are no wellhead pressures) all Wellhead valve & accessories and downhole safety valves. Check that leak rates are in accordance with API/Company standard and chart such tests.
- Trouble shoot and determine nature of failure for downhole safety valves that fail test.
- Grease all wellhead valves and accessories with API grease.
- Repack tubing hangers with standard plastic sticks and re-test same.
- Check and retighten all flange connections, valves etc to manufacturers standards and specifications.
- Provide end of well reports for scope of work carried out on all wells.
- Provide end-of-well maintenance activities reports.

B: Second line/Corrective Maintenance services as per industry best practice on flowing (oil/gas), shut-in or suspended wells covering land, swamp and offshore and includes as a minimum:

- Maintenance & repair of all wellhead equipment excluding Xmas tree valve replacement and Xmas tree removal.
- Xmas tree valve replacement, Xmas tree removal and Installation, setting of tubing hanger NRV's and casing plugs NVRs plus the performance of specialist repair and test services as required.
- Change out of gate/seat assembly or the complete valve, change out damaged bean boxes, change out/repair SSV's, change out or repair control-o-matic units, change out defective studs, pressure/leak test Xmas tree as required and record tests on test charts. Remove and install Xmas tree at location etc.
- Miscellaneous services will include major painting of wellheads, workshop services, testing and repairs, servicing and repair of ligament valves from flow stations and the supply of wellhead / Xmas tree maintenance materials including but not limited to greases, oils, lubricants etc.
- Provide end-of-well maintenance activities reports.

C. Others

- Installation of Annulus Pressure Monitoring (APM) retrofits (to extend annulus pressure gauges above valve level)
- Installation of Anti-theft bolts and nuts (to be provided by company)
- Provision and application of industry standard High performance sealant grease (e.g. RS Clare valve lubricant 601 & 701) on wellhead valves.

2.0 Mandatory Requirements

- To be eligible for this exercise, interested Tenderers are required to be prequalified in the Service Category: **3.04.19 – Wellhead Services** in the NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified suppliers in this category will receive a Technical and Commercial Invitation to Tender (ITT).
- Bidders must comply with Nigerian content requirements.
- To determine if you are pre-qualified and to view the product/service category you are listed for, log on to www.vendors.nipex-ng.com and access the NJQS with your log in details, click on "Continue to Joint Qualification Scheme tool", click on "check my supplier status" and then click "Supplier product group".

- To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

NIGERIAN CONTENT REQUIREMENTS

Tenderers are to note that they will be requested during the technical tender to give full details of their relevant strategy to ensure that they fully comply with the Nigerian Oil & Gas Industry Content Development (NOGICD) Act, 2010 as non-compliance will constitute a FATAL FLAW in all tender evaluations. In line with the above, Tenderers will be required to ensure that information on the following, among others, is included in their technical submission:

- Tenderer shall demonstrate that entity is a Nigerian-registered company with 51% or more shareholding capacity. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc.). Tenderer shall provide evidence of registration with the NCDMB NOGIC JQS and NUPRC.
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Tenderer shall provide evidence of Category 1,2,3,4 or 5 Service and Support group NCEC demonstrating capacity to perform well head maintenance and ownership of Wellhead maintenance equipment.
- Detailed description of the location of in-country committed facilities & infrastructure. (Technical/Administrative office, maintenance workshop, etc.) in Nigeria to support this contract.
- Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

- Only tenderers who are registered with NJQS in the **relevant** Product/Service category and their registered status are current and not expired as at **1600hours** on the **24th of July 2024** being the advert closing date shall be invited to submit Technical Bids.
