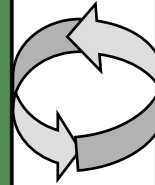

The Joint Qualification System (JQS) is designed to pre-qualify Suppliers registered in Nigeria. It increases efficiency and instills integrity in the pre-qualification process of the Nigerian oil and gas industry.



The eMarketplace is a collaborative environment that delivers significant value to all Stakeholders in the contracting process through a comprehensive suite of capabilities.

ACCESSING THE NipeX SYSTEM

WHO PUBLISHED THE TENDER?

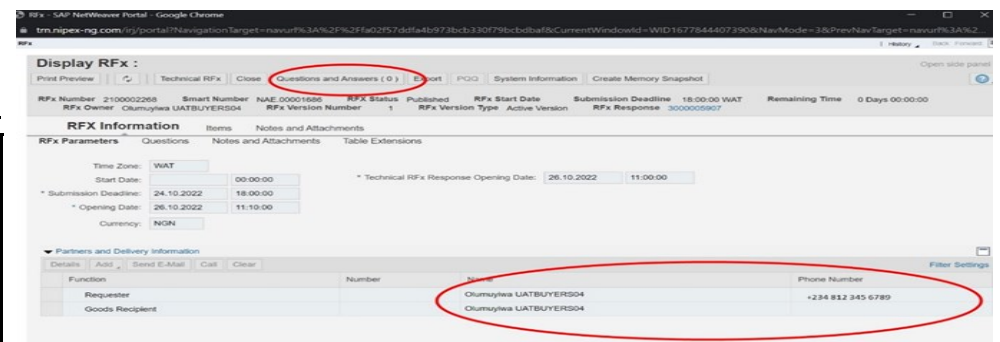
The NipeX eMarket is the second half of the NipeX system wherein suppliers download and respond to tenders published to them. The other half of the NipeX system is the NipeX Joint Qualification System (NJQS) Database wherein the product codes of vendors, their contact details, subscription status, as well as company documents and details are stored and managed.

Since tenders are not published by NipeX on the eMarket, suppliers (vendors/bidders) can only seek reach out to NipeX for assistance in the following:

1. Navigation of the eMarket
2. Download and upload of documents on the eMarket.
3. Clarification on tenders that ought to have been received with respect to the condition(s) stated on an advert.

However, for clarification on the details of tenders received, suppliers (bidders/vendors) are to contact the operators (buyers) as they are the party that published the tender(s).

The contact details for the buyers can be found in the lower right corner of the RFX (tender). Clarifications can also be sought via the "Questions and Answers" tab in the RFX (tender) on the eMarket.



The contact details of the buyer may also be found as part of the content of the documents published by the buyer(s).

It is important to also note that NipeX does not also send out meeting invitations for pre-bid (pre-tender) clarification meetings.

Frequently Asked Questions:

Question: When does a Supplier’s registration subscription on NipeX expire?

Answer: A supplier’s subscription expires on the anniversary of the company’s first registration with NipeX. A mandatory annual update of the questionnaire is required and failure to subscribe annually in the NJQS database will make it impossible to receive future Tenders. (Please note that it is not from your date of renewal payment).

Question: Is the NipeX pre-qualification audit going to cut off the technical site visit for some tenders?

Answer: No, the pre-qualification audit will not stop technical site visit for some tenders. NipeX pre-qualification audit is distinct/different from technical site visit.
